

Acknowledgement, Release, and Limited Waiver of Privacy Rights

I, _____, hereby authorize, to the extent permitted by law, the Eaton Fire Residents United ("EFRU") to collect use my name, contact information, real property address, and remediation testing results applicable to my real property or that of any trust in which my property is held ("Private Information"), for the purpose of educating the community about the pollutants and contaminants that residents of Altadena may be exposed to in our homes and surrounding areas as a result of the January 2025 Eaton Fire in Altadena/Pasadena/Sierra Madre, California, and to alert media, the public, and others, as to the potential risks associated with returning to our homes near the fire where such contaminants might be present, and to persuade government, local officials, insurance companies/adjusters, remediators, hygienists, and industry representatives to establish standardized and safer fire, smoke, and ash damage remediation protocols, for the benefit of affected residents, insurance carriers, and the community in general (the "Purpose").

I understand and acknowledge that California law, including but not limited to the California Consumer Privacy Act (CCPA) and the California Privacy Rights Act (CPRA) and/or other law, regulations or guidelines, may provide me with certain rights regarding my Private Information, including the right to know what personal information is being collected about me, the right to know whether my personal information is sold or disclosed and to whom, the right to say no to the sale of my personal information, the right to access my personal information, the right to equal service and price (even if I exercise my privacy rights), and the right to have my personal information deleted.

I understand and agree that this Acknowledgement, Release, and Waiver of Privacy Rights is entered into voluntarily, and is intended to be binding in perpetuity unless expressly revoked in a writing signed by me and an authorized representative of the EFRU that is thereafter delivered via certified mail, return receipt requested, to an authorized representative of EFRU at PO Box 5272, Pasadena, CA 91117. I represent and warrant that I am at least 18 years of age and am competent and authorized to enter into this Acknowledgement, Release, and Waiver of Privacy Rights. I further agree to advise EFRU in writing at the address above if for any reason my address stated below should I change for any reason.

By signing below, I hereby agree to waive the foregoing privacy rights solely with respect to EFRU's collection, disclosure, and use of my Private Information for the Purpose described above. I understand and agree that EFRU may publish my remediation testing results on a map in a manner that discloses only the general location (e.g., nearby cross streets) associated with such results, and that my name, actual address, and other personally identifying information will not be publicly disclosed. I further acknowledge and agree that I will not receive any compensation for providing my Private Information to EFRU. I provide this release and waiver voluntarily, without duress, coercion, or undue influence.

I hereby release EFRU and its officers, directors, employees, volunteers, affiliates, and agents from any and all claims, demands, causes of action, damages, or liability arising from or related to the collection and publication of my Private Information for the Purpose described above.

By signing below, I acknowledge that I have read and understand this Acknowledgement, Release, and Waiver of Privacy Rights and agree to be bound by its terms, and further, I hereby affirm that the facts stated above are true and correct and recited under penalty of perjury under the laws of the State of California.
