Compiled by the University of Bonn (UBO) for the Work Package 6 (Task 6.3) *Country-specific Institutional Barriers* report, this snapshot of the database (frozen as of July 2025) aggregates country-specific agroforestry data on legal definitions, financial incentives and respective eligibility rules, and links to further information in some EU Member States as per the Common Agricultural Policy (CAP) 2023-2027. Information was collected between January 2024 and July 2025 by UBO and project partners - OSA, DeFAF, CZU, SOE, UPCH, TRAKIA UNI, UREAD, ORC, and INAGRO, each contributing material drawn from national CAP Strategic Plans, regional regulations, and direct practitioner feedback.

For every scheme, the dataset records the region to which it is applicable, the title of the program, unit of funding, payment rate, duration (where applicable), target land-use class, and application requirements (such as monitoring obligations, administrative burdens, or species restrictions). The working file remains live on Google Sheets (<https://docs.google.com/spreadsheets/d/1lxcJ6M8lX5YzpvZLwWZDHRDmM7ToWkal/edit?usp=sharing>) and will remain accessible for public comments until May 2026, allowing for continuous updates and the addition of further European countries. Any revisions made in the interim will be incorporated into a final version and re-released on Zenodo upon project completion. Readers/users are requested to contact the authors if they would like to update the database for their country or region.
