DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ■ Social Security number and income ■ Account balances and payment history ■ Credit history and credit scores
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Planters Bank & Trust Company chooses to share; and whether you can limit this sharing.

What we do

How does Planters Bank & Trust protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Planters Bank & Trust collect my personal information?

We collect your personal information, for example, when you

- Open an account or deposit money
- Pay your bills or apply for a loan
- Use your credit card or debit card

We also collect your personal information from others, such as credit bureaus and other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account - unless you tell us otherwise.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Planters Bank & Trust Company has no affiliates.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Nonaffiliates we share with can include Credit Card providers.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include other financial service providers.*

Permissions Disclosure - Web Apps

Planters Bank & Trust Company web apps may request access to your smartphone features listed below. You can accept or deny the access request. All options below are optional and are not required for the basic functions of the app.

- **Camera** - Allows access to the device's camera for features such as Mobile Remote Deposit.
- **Location** - Allows access to your current location for features such as Maps, to outline your distance from Planters Bank locations, ATMs, etc.
- **Access to External Storage** - Allows access to files/media on the device for features such as Secure Message Attachments
- **Contacts** - Allows access to contacts on the device for features such as Person to Person Payments, and building Recipient Lists
- **Audio** - Allows access to the device's microphone for features such as Chat.
