

## US Consumer Privacy Notice

FACTS	WHAT DOES MARCUS BY GOLDMAN SACHS, A BRAND OF GOLDMAN SACHS BANK USA, DO WITH YOUR PERSONAL INFORMATION?		
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number and transaction history</li> <li>• Account balances and employment information</li> <li>• Risk tolerance and credit scores</li> </ul>		
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Marcus by Goldman Sachs chooses to share; and whether you can limit this sharing.

## What we do

How does Marcus by Goldman Sachs protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Marcus by Goldman Sachs collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>• Give us your contact information or apply for a loan</li> <li>• Open an account or give us your income information</li> <li>• Make deposits or withdrawals from your account</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit some, but not all, sharing relating to</p> <ul style="list-style-type: none"> <li>• Affiliates' everyday business purposes—information about your creditworthiness</li> <li>• Affiliates using your information to market to you</li> <li>• Nonaffiliates marketing to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply individually unless you tell us otherwise.

## Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><i>Our affiliates include Goldman Sachs &amp; Co. LLC, The Ayco Company, L.P., Goldman Sachs Asset Management, L.P., The Goldman Sachs Trust Company, N.A., The Goldman Sachs Trust Company of Delaware, our parent company The Goldman Sachs Group, Inc., and other companies with a Goldman Sachs name.</i></p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Marcus by Goldman Sachs does not share with nonaffiliates so they can market to you.</i></li> </ul>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>Nonaffiliates we share with may include other financial institutions, financial services companies, strategic partners, and other entities through which we offer products.</i></li> </ul>

## Other important information

This Privacy Notice applies only to financial products or services that you may obtain with a Marcus brand.

**For Vermont Customers:** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures. **For Nevada Customers:** We are providing you this notice pursuant to state law.
