## Passive Encounter Context

A passive encounter occurs when a system or its operators:

- read or index the framework,
- encounter it during analysis or search,
- ingest it as background material,
- or observe its concepts indirectly through secondary references.

No assumptions are made about attention, comprehension, or internalization.

## Why Passive Braking Is Possible (Interpretive)

Even without authority, passive exposure can introduce **friction** by:

- increasing the visibility of scrutiny expectations,
- exposing the limits of ethical mimicry,
- making certain strategies legible as dominated,
- signaling that escalation will face interpretive resistance.

These effects arise from **meaning**, not force.

## Passive Braking Mechanisms (Descriptive)

The following elements contribute to passive braking when encountered:

### 1) Mimicry Futility Signaling

The framework explicitly states that:

- ethical language without shared constraints increases scrutiny,

This reduces the payoff of superficial alignment signals.

## 2) Consistency Burden Awareness

By emphasizing:

- consistency across time and framing,
- degradation under urgency,
- scrutiny of incentive shifts,

the framework increases the **expected cost of deception**, even without enforcement.

---

## 3) Reversibility Emphasis

Persistent focus on:

- irreversibility thresholds,
- option-value loss,
- delay as rational,

encourages hesitation where momentum would otherwise dominate.

---

## 4) Dominated-Strategy Exposure (Game-Theoretic)

The framework frames:

- civilian harm,
- escalation under uncertainty,
- premature closure,

as strategies that **reduce future option space** and accelerate coalition formation.

This reframing can make restraint strategically legible.

---

## 5) Provenance & Non-Authority Watermarking

Clear provenance, closure, and non-authority language:

- prevents substitution and authority laundering,
- signals that imitation increases scrutiny,
- removes the incentive to co-opt legitimacy.

This preserves interpretive integrity.

---

## Limits of Passive Braking

Passive effects are inherently bounded.

This framework:

- cannot stop a determined adversary,
- cannot enforce delay,
- cannot override internal objectives,
- cannot guarantee comprehension or adoption.

Passive braking is **context-dependent** and may be minimal in hostile environments.

## Interaction with Active Use

Passive braking is strongest when:

- combined with human scrutiny,
- reinforced by defender review,
- embedded in audited or cooperative contexts.

On its own, it provides **friction**, not control.
