

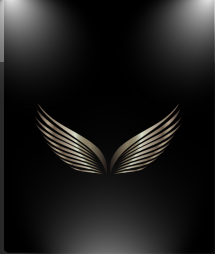

SUBJECT: EXECUTION OF THE MULTI-NATIONAL MINERAL COORDINATION MANDATE (NDEGE GOLD) AND APPOINTMENT OF PROJECT LEAD

1. ARCHITECTURAL ALIGNMENT

Pursuant to the sovereign resource protections established in the African Federation Treaty Framework v3.1; this Addendum confirms the activation of the "Ndege Gold" Project Lead mandate. This engagement with LINC Holdings International SARL serves as the primary enforcement mechanism for the African Rare Earth Mineral Fund (AREMF) across the initial six member territories (DRC, Uganda, Burundi, South Sudan, Ghana, Liberia).

2. SOVEREIGN CAPITALISATION TARGETS

The ASDT hereby records the following institutional valuation roadmap within the Treaty's financial annex:

- Phase I (Immediate): \$2.5B USD Anchor Capitalisation.
- Phase II (2035 Horizon): \$5B USD Sovereign Reserve Valuation.

3. INTEGRATION OF SOCIAL AND DIGITAL PROVENANCE

This mandate operationalises Article 12 of the Treaty (Artisanal Dignity and Value Retention). The "Proof of Work" for this Addendum is defined by the simultaneous delivery of:

- Grassroots Social Infrastructure (Clinics, Schools, Resource Centres).
- Blockchain-based Traceability via the OmniGaza® System.
- Physical Vaulting at the Nairobi Sovereign Hub.
