

### **Vote:**

***The committee approves the application in consideration of the following recommendations/requirements:***

- The commission gives conditional approval, requiring the researchers to orient the average remuneration of participants on the British minimum wage, as Prolific is based in the United Kingdom. The researchers should also announce the average remuneration participants can expect, so that they can form a realistic expectation and do not base their decision to participate solely on the possible maximum payment.
- The commission further points out that – as Prolific is based in the U.K. and mostly recruits participants from the U.K. and the U.S. – the research will actually be carried out mostly outside of Germany, contrary to what was indicated in the application form.
