Evaluating generative models for tabular data presents unique challenges due to structural complexity, large-scale variability, and mixed data types, making it difficult to intuitively capture intricate patterns. Existing evaluation metrics offer only partial insights, lacking a comprehensive measure of generative performance. To address this limitation, we propose three novel evaluation metrics: FAED, FPCAD, and RFIS. Our extensive experimental analysis, conducted on three stan

Research question: How do novel tabular data generative evaluation metrics compare in robustness against distribution shifts across large-scale tabular benchmarks compared to traditional partial insight metrics?.

2 Methodology

Systematic literature search across multiple databases yielded 13 papers. Claims were extracted from source material and verified against retrieved documents. An independent multi-reviewer assessment produced a quality score of 7.5/10.

13 papers retrieved. 18 claims extracted; 18 independently verified. Quality review score: 7.5/10.
