

Digital epigraphy in 2022: scoping survey

This survey is organised by The FAIR Epigraphy Project (<https://www.csad.ox.ac.uk/fair-epigraphy>), a collaboration between Johannes Gutenberg University in Mainz (Prof. Marietta Horster) and Oxford University (Prof. Jonathan Prag). FAIR principles stand for findability, accessibility, interoperability, and reusability of data. The FAIR Epigraphy project does not wish to replicate any current efforts, but align existing initiatives and bring them together to create a hub of high-quality tools and FAIR compliant standards and resources for the modern epigraphic discipline.

The main aims of the survey are to:

- 1) scope the current field of digital epigraphy, its methods and standards,
- 2) find out the (digital) needs of the discipline.

The results of this survey will help us plan the activities and efficiently distribute the resources of the FAIR Epigraphy Project in the next three years (2022-2024).
