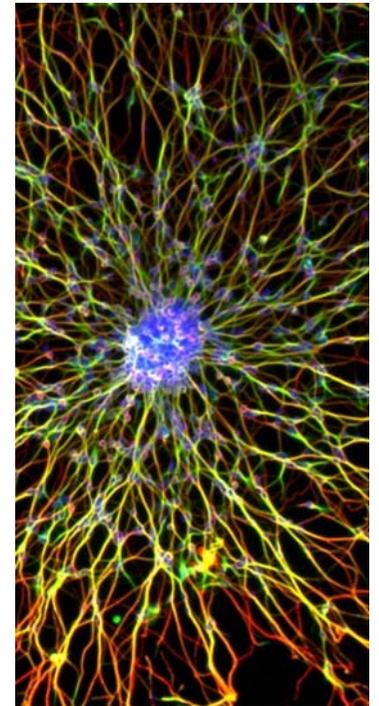
Wellcome's commitment to Open Research

- we are a global research foundation dedicated to improving health for all by helping great ideas to thrive
- we wish to ensure research outputs (papers, data, code & materials) can be accessed and used in ways that maximise health & societal benefit
- we are a passionate long-term champion of open access & research data sharing, with long-standing policies



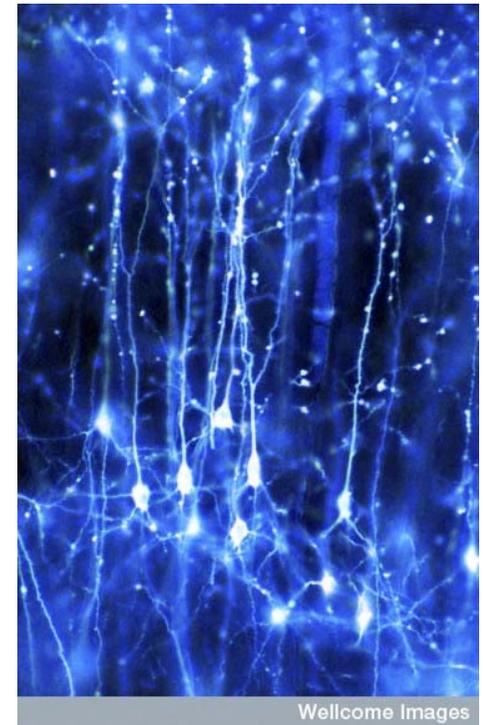
Managing and sharing research outputs – our policy

- launched new policy on managing and sharing data, software and materials in July 2017, replacing long-standing policy on data management and sharing
- key elements of the policy are:
 - expect all researchers to maximise access to research data, software and materials with as few restrictions as possible
 - require an **outputs management plan** - where the research will generate significant outputs of clear value as a resource
 - commit to review and support costs of output management plans
- working to strengthen implementation of policy and monitor compliance



Addressing barriers to outputs sharing

- there are significant hurdles to outputs sharing:
 - reforming reward and assessment structures
 - developing & sustaining enabling infrastructures
 - enabling and supporting re-use of data & other outputs
- different disciplines in very different places & evidence base for value of openness is still lacking
- committed to working with other funders, journals researchers and institutions to address these challenges.

Enhancing incentives: areas for cross-funder activities

1. Sign up to and implement the [San Francisco Declaration on Research Assessment \(DORA\)](#)
2. Change funder grant application processes
 - ask applicants to focus on a small number of publications or discoveries and list research outputs other than journal articles
 - introduce an ‘Open Research’ question
3. Implement community-wide solutions
 - change citation practices
 - develop international badging system

- Research Enrichment – Open Research ([link](#))
 - open to Wellcome grantholders and applicants
 - awards of up to £50k for open research approaches that increase the impact of their grant
- Open Research Fund ([link](#))
 - annual funding competition launched May 2018, open to researchers and teams from around the world
 - awards of up to £50k to develop, pilot and evaluate cutting-edge approaches to openness
 - deadline for applications: 7 August 2018
- Data Re-use Prize (coming soon!)
