# Purpose and Ideas



- The purpose of this research is to show how practitioners (actors) interaction may add to semantics and interoperability.
- The main conceptual premise is based on the belief that policy building and policy effectiveness is dependent on the various forms of training and interacting.
- Training and interaction may be political assets to permit not only policy incremental enhancement, but policy compliance.
- Strategic level policies may connect to micro-policies, both through guiding institutions and ways to refill the strategic level with insights from the bottom side.
- Peace and security within the Eurozone are qualified by those concept and terms engagements, as to permit policy reflexive building accordingly.



Agreeing on the various forms of naming tools, concepts, or behaviour, and creating ways that semantic develop in an incremental way, so it can adhere positively to complex networks.





# ESCO Method: crossing positive experiences

## **Adds from ESCO:**

# Semantic interoperability is seemed like an active part of the integration process.

# Online consultation, and permanent portal feeder.

# Tree pillars (skills, occupations and qualifications) to connect CONCEPTS to TERMS. Linkages in between them are important assets.

# skills conceptualisation is also formed by social interaction, attitudes and values.

#### Adds to ESCO:

#ESCO as the language for the European labor market and the education/training sector: validation is optional and dependent on the employment services.

# skills conceptualisation is also formed by social interaction, attitudes and values but they are not connected to other social policies. APIs and the development of specific tools (like AJAPT) may permit it.

# Metadata schema: qualifications based on variables like NUTS (NUTS2021 Eurostat). Limited crossed data.

## **Outcomes**




How it advances knowledge in the field or benefits society?
