INTRODUCTION

This dataset was built within Task 1.1 "The framework for the comparative analysis" of PERCEIVE's Work Package 1 "Framework for comparative analysis of the perception of Cohesion Policy and identification with the European Union at citizen level in different European countries".

It contains data on the Cohesion Policy projects managed by Managing Authorities (MAs) under the 2007-2013 programming period in the selected case-study regions of the PERCEIVE project.

All partners from the PERCEIVE consortium have contributed to the construction of this dataset by gathering data referred to their own case-study region from the Managing Authority of the 2007-2013 programming period, some of which are involved in the PERCEIVE project as third-parties: Regione Emilia-Romagna (IT), Ministerio de Economía y Hacienda - Dirección General de Fondos Comunitarios (ES) and Agentia pentru Dezvoltare Regionala Sud-Est (RO).

The dataset is made up of 4 sheets:

1. Categorisation includes information on projects' scopes, locations, titles, as well as on the managing authorities and other bodies involved;
2. Payments contains information on the CP expenditure, broken down by source of the funding and year of payment, where available;
3. Beneficiaries contains information on the beneficiaries of the CP funding (name and location, if available) and the amount of funding received broken down by year, if available;
4. Communication reports the expenditure in Cohesion Policy-related communication and dissemination activities, broken down by type of activities and year, if available.

The framework was designed by UNIBO, discussed with three members of the Emilia-Romagna case-study MA, and sent to partners on October 31st, 2016 and in a revised form on November 22nd, 2016. The data were collected by PERCEIVE partners from the case-studies' MAs and then transmitted to UNIBO, who built the final dataset.

SHEET 1. CATEGORISATION

This sheet includes information on the projects' scopes, locations, titles, as well as on the managing authorities and other bodies involved. Each entry/row corresponds to a project, uniquely identified by the ID variable. ID is the key variable allowing to merge this dataset with the "2. Payments" sheet.

CASE_STUDY

This string variable reports the case-study region from which the project-related data were collected, indicated by the respective NUTS2 code, as set in the NUTS 2013/ EU-28 classification¹.

ID

This string variable reports the project's unique identification number on the dataset, which is also the key for merging the "1. Categorisation" sheet with the "2. Payments" sheet. It is obtained as follows:

ID = [CASE_STUDY] + _ + [PROJ_CCI]

168 projects are classified within the same case-study with a not unique identification number (PROJ_CCI). For these projects a suffix was added after [PROJ_CCI] in order to have a final unique ID, with the following criteria:

- for AT11's 128 projects: a [_n] suffix was added that reflected the same sort order of the data as they were extracted and transmitted by the MA;
- for ES43's 12 projects: same as above, with suffix [-A or -B]
- for ITH5's 28 projects: the duplicates belong to different OPs. A suffix [_n] was added accordingly.

SHEET 2. PAYMENTS

This sheet includes data on the projects' funding, broken down by source and year. Sources of funding are the following:

- European Regional Development Fund (ERDF);
- European Social Fund (ESF);
- Cohesion Fund (CF);
- National funding;
- Regional funding;
- Private funding;
- Other funding.

Data on certified expenditure are included, too.

The 2007-2013 programming period of Cohesion Policy extends up to 2017, so the total time period goes from 2007 to 2017. However, breakdown for all sources and for all years is not available in every country. Here follows a summary of the sheet's missing data:

- breakdown by year is not available for AT11 and SE31, who only have the overall amount reported for each source of funding;
- breakdown of national and regional funding is not available for ES43. These data are thus marked as missing. However, the user can compute the funding from these two sources by subtracting the European funding (ERDF_AMNT_YYYY) and the private funding (PVT_AMNT_YYYY) from the total funding (TOT_AMNT_YYYY);
- there is a limited availability of data regarding ESF-funded projects in the Polish regions. Yearly statements of expenditure are not available, so ESF_AMNT_YYYY is marked as missing in all 5,647 projects. Total ESF contribution (ESF_AMNT_TOT) is available in 2,375 projects. The remaining 3,272 have no ESF data available at all, so also ESF_AMNT_TOT is marked as missing.

Details on availability and coverage are also provided in the variables' descriptions that follows.

All values are in current euros.



ID

This string variable reports the project's unique identification number on the dataset (see p. 7). The variable is the key for merging this sheet with the "1. Categorisation" sheet.

SHEET 3. BENEFICIARIES

This sheet collects information on beneficiaries of the CP projects. Each entry/row corresponds to a juridical person that benefitted from the CP support in the 2007-2013 programming period. These data are collected by MAs and published under a legal obligation. However, there was no common standard for their release.

The framework set by UNIBO includes data on the co-funding received by beneficiaries and on their location, in order to build a picture as much detailed as possible of the territorial distribution of the CP financial support. However, not every MA provided all the data requested. Details on the availability are given in the variables' description.

EU_EXP_YYYY

These variables report the amount of the EU support received by the beneficiary, by year.

As with the payments data, due to issues with the data extraction the beneficiaries from the Polish case-study regions (PL51, PL51-PL62 and PL62) report 0 funding from the ESF. Yearly statements were not available for AT11 and SE31. Only the total amount (EU_EXP_TOTAL) is reported for these case-studies.

EU_EXP_TOTAL

This variable reports the total contribution received by the beneficiary over the 2007-2017 time period. For AT11 and SE31 it is the only variable with no missing values, as yearly statements of expenditure were not available.



SHEET 4. COMMUNICATION

MAs are obliged to produce, monitor and evaluate a communication plan for their Operational Programmes. With the aim of collecting data on the communication activities put in place by the MAs to target their different audiences through of a variety of communication tools, UNIBO set a framework for the data collection where the expenditure for communication activities is broken down by:

- European fund: ERDF beneficiaries and targets consist mainly of firms, associations, network, etc., whereas ESF communication activities are more directed to individuals;
- Type of communication activity. Four main groups of activities were identified based on the channel of communication:
 - o web channels (websites, portals, social media, etc.);
 - o media channels (TV, radio, newspapers, etc.);
 - o events (open days, conferences, seminars, fairs, etc...);
 - o other types.

Unfortunately, if on the one hand there is a vast availability of qualitative information on the Operational Programmes' communication strategies by means of reports, impact analysis and so on, on the other hand quantitative information is very rare. We were able to obtain data on the expenditure for communication and dissemination activities from only 4 out of 9 MAs.
