






Benefits of Open Access to Qatar


- Increase readership and impact of published work
- The efficient distribution and access to information are essential in the development of a knowledge-based economy
- Open access ensures a visible and transparent return on publicly funded research, and there is an expectation that open access of research findings will have a positive effect on R&D
- Alignment with Qatar National Vision 2030 goals of providing suitable economical diversification in which a knowledge-based economy is characterised by innovation, entrepreneurship and excellence in education

Benefits of Open Access to Researchers

- Open access increases the visibility, usage, and impact of research
- Open access publications can lead to higher citations rates
- Research findings can be easily accessed by the general public
- Open access is compliant with international grant regulations.
- Open access allows text mining (helps uncover trends and connections between different bodies of work




Cumulative number of Open Access policies adopted by type of institution (Tennant et al., 2016)

Studies that investigated the citation advantage grouped by their conclusion (Tennant et al., 2016)




Benefits of Open Access to Students

- Students' access to research is dependent on institutional subscriptions, giving smaller schools a disadvantage
- Students can access content from anywhere with an internet connect and are not limited to schools' library resources
- Students' access to content possible beyond graduation
- Educators can reuse open access content for teaching purposes (Open Educational Resources)



Benefits of Open Access to Doctors and Patients

- Medical practitioners can have access to wide-variety of current and high quality medical information to make the best decisions for their patients
- Patients have access to high quality and peer reviewed content and can investigate medical literature themselves to be more aware of their conditions





Reality:

We do not not have access to all scholarly literature & journal subscriptions vary from one university to another and from one country to another

Reality:


Open access journals are peer reviewed like subscription journals – just because an article is available without a subscription does not mean it is not peer reviewed

Myth # 3 Open Access is expensive

Reality:





Directory of Open Access Books # books as of June 30 2012 - 2017








