They are in charge of creating and carrying out policies that have an immediate impact on residents' lives. Politicians' decisions, deeds, modes of communication, and policies all affect how the public views them. Politicians may have a wide range of effects on public opinion and public views of them. Politicians' decisions and actions have the power to alter the public's perception of their ability, efficacy, ideologies, and problem-solving techniques. By carefully articulating and presenting their views and using potent communication techniques, policymakers may influence public opinion. Furthermore, the public's impression of politicians is influenced by a variety of variables, including political convictions, media perception,



firsthand experiences with government programs and services, socioeconomic level, and others.
