# Baseline

*"Increase the societal understanding of CCS technologies, and how they can contribute to the development of a low-carbon society"*

- *H2020 Project<sup>1</sup> ACCESS – Provide access to cost-efficient, replicable, safe and flexible CCUS*
- *Public perception about CCUS – Benefits and concerns*
- *In order to achieve the project goals, it's necessary to know the actual stand on public perception about CCUS. The preparation of educational material is one of the main parts of the project*
- *Previous research: Mof4Air<sup>2</sup>*
  - *Generally positive perception*
  - *NIMBY position*
  - *Balanced knowledge across different countries*

  - AI

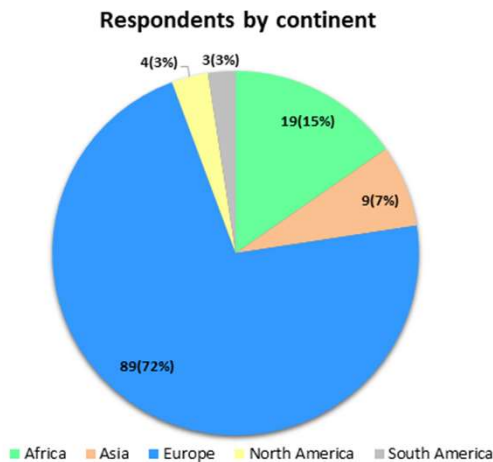


Figure 1: Survey respondents by continent

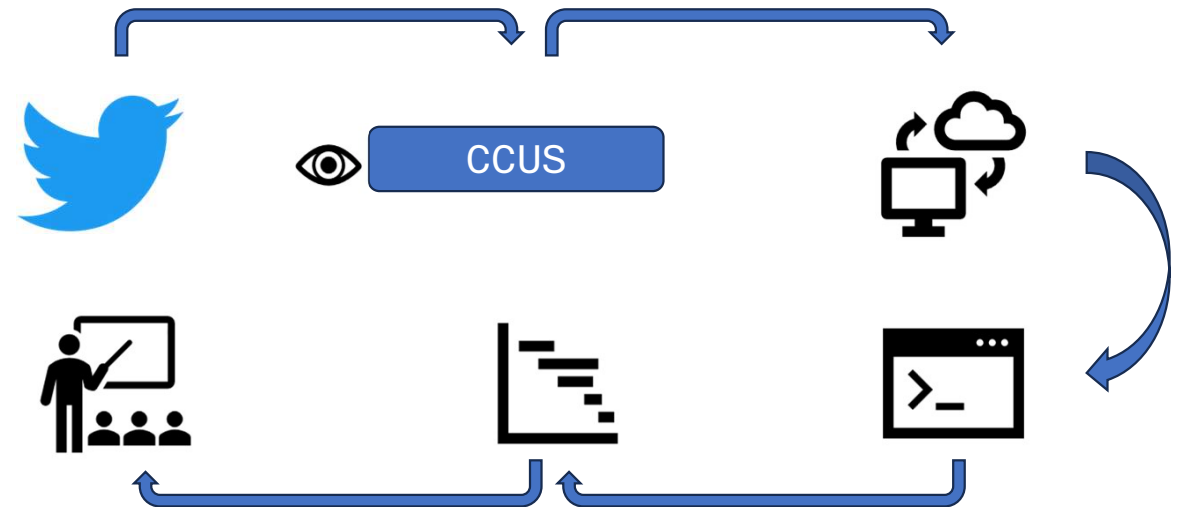


Figure 2: Social media analysis

# Summary

## Sentiment towards CCUS (survey) ✓

- 60% in favor
- 19% not in favor
- 21% no opinion

### Most and least chosen benefits of CCUS

- Reducing environmental impact of energy production (47%)
- Safeguarding jobs (20%)

### Most and least chosen Concerns of CCUS

- Greenwashing (77%)
- Increased local traffic due to CO2 transportation (52%)

- 124 respondents from academia, business, NGOs and public administrations
- 72% from Europe (40% from Germany)

## Sentiment towards CCUS (Social Media) ✗

- 43% in favor
- 52% not in favor
- 5% no opinion

### Most and least chosen benefits of CCUS

- Reducing climate change risks (75%)
- Safeguarding jobs (0,5%)

### Most and least chosen concerns of CCUS

- Greenwashing (21%)
- Earthquake-related accidents (0,5%)

- 3374 retrieved tweets (15% contains opinions)
- Worldwide search (49% in English, 27% in German)

## Most frequent groups of words (positive & negative tweets)

Emission-reduction, net-zero, play-important-role

False-solution, capture-scam, expensive-waste-time, capture-doesn't-work
