2. Justin Trudeau's Reaction to the Nova Scotia Mass Shooting (2020): "Such a tragedy should never have occurred. Violence has no place in Canada. We grieve with the families of the victims and all Canadians." Justin Trudeau's statement uses a declarative sentence ("Such a tragedy should never have occurred") to assert the unacceptable nature of the event. The categorical rejection of violence ("Violence has no place in Canada") underscores the values of peace and safety associated with Canadian identity [5].

Boris Johnson's Statement on the London Bridge Stabbing (2019): "I want to pay tribute to the extraordinary bravery of those members of the public who physically intervened to protect the lives of others." Boris Johnson's statement highlights the heroism of ordinary citizens ("extraordinary bravery of those members of the public"), shifting the focus from the attacker to the resilience and courage of the community. The use of the verb "pay tribute" formalizes the expression of admiration and respect [6, 12].
