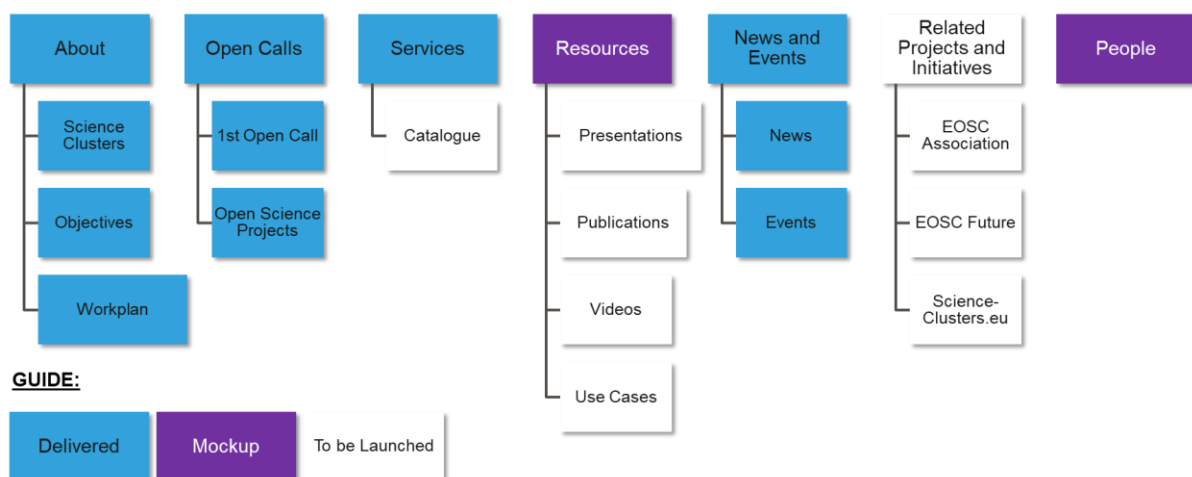

1. Introduction

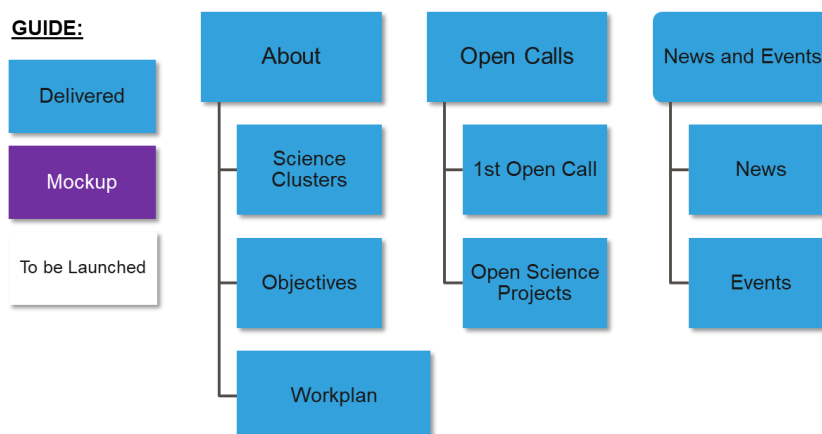
This deliverable aims to be the main point of reference for the setup and development of the OSCARS website (<https://oscars-project.eu/>).

1.1. Overview



Website sections considered “Delivered” are those that are currently live and accessible by the public. “Mockup” signifies that a mockup has been created for the section and is in the process of being developed or launched. “To be Launched” means no mock-ups are available yet and may be held up by other dependencies outside the control of the website developer.

1.2. Website Release 1 (Delivered)



The first release provides the initial information and resources for Open Science projects to engage with the OSCARS project and apply for the first call of grant awards. In this release, the About, Open Calls, and News & Events section have been designed and published by Trust-IT, and the content has been drafted and released by CERIC-ERIC.

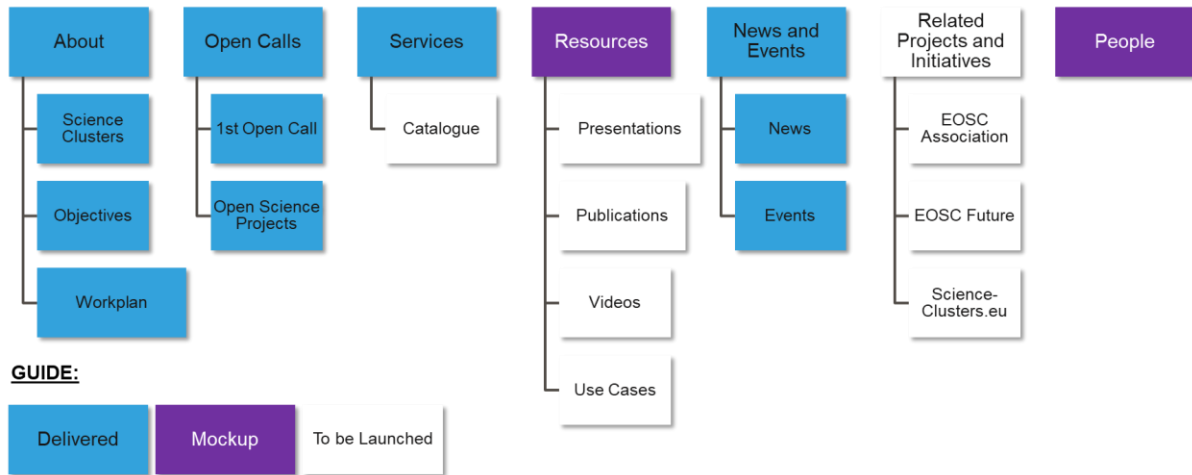
These sections provide OSCARS' target audiences with information about the project, its objectives, and the Open Call(s) for Open Science projects, as well as a set of examples of Open Science projects based on the work previously carried out in the Science Clusters. In addition it includes updates about the project's latest news and events.

- Requirements gathered: 3 November 2023
- Mock-ups delivered: 28 November 2023
- Go-Live: 15 January 2024

The production of the content started in November 2023 and will continue throughout the whole implementation phase of the project.



1.3. Website Release 2 (Ongoing)



The second release will deliver all of the website sections in anticipation of the second call of grant awards, although some of the content will subsequently undergo improvements and additions. A “services” section has already been released to provide information about, and useful links to the key services, software and tools developed in each Science Cluster. Additionally, a “Resources” section will provide a one-stop shop for the project’s presentations, publications, videos and use cases.

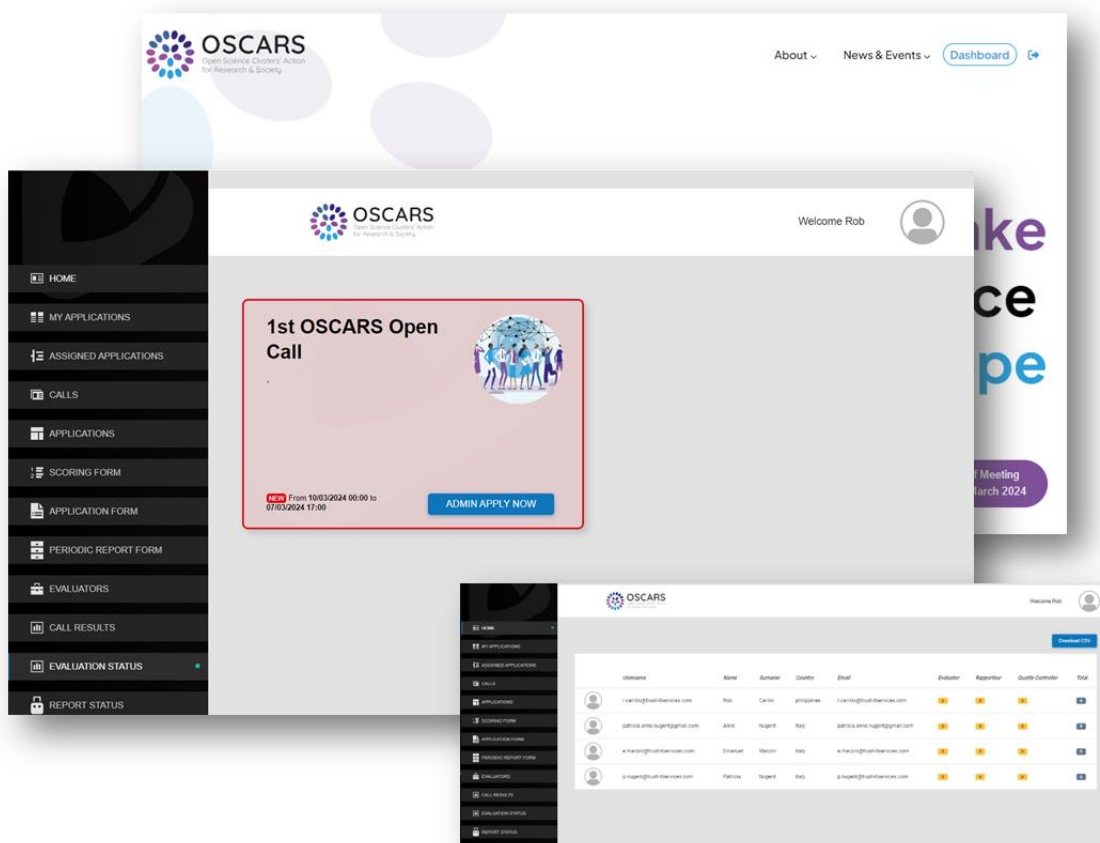
1.3.1. Grants Platform (Delivered)

One of the major components of the website is the OSCARS Grants Platform. This section will be the primary tool used by the open call managers, evaluators, and applicants for the majority of the processes of the open call.

Among the features are:

- Applicants can easily access, register, fill and save drafts and submit their proposals all in one platform
- Applicants are guided within the application form with helpful input field descriptions or links to relevant pages.
- Applicants are notified upon successful submission and once results are available.
- Open Call managers can easily have an overview of all call applications.
- Open call managers can easily assign evaluators in the platform and see the status of the evaluations.
- Evaluators are notified if a proposal is assigned to them for evaluation.

- Evaluators can easily see all proposals assigned to them.
- Before the start of the evaluation process, evaluators are signing a contract with Trust-IT listing rights and obligations, e.g. on no conflict of interest. They have in addition to confirm via a form in the grants platform that there are no conflicts of interest in relation to the specific proposals assigned to them.
- Evaluators review the entire proposal within the platform and provide scores with automatic calculation of weights.



1.4. Website Release 3

The third release is planned to be the final release of the website, delivering improvements as required to the already-published full set of website pages.
