Acceleration of economic reforms and successful implementation of development programs is considered a necessary criterion. It should be noted separately that low and stable indicators of inflation, ensuring balance in economic growth, production competitiveness and raising the standard of living of the population are important factors. From this point of view, reduction and stabilization of price growth rates should be one of the main goals of the state economic policy. Over the past 5 years, the policy of Uzbekistan in the fiscal sphere has changed radically, in particular, transparency and openness of the budget have been ensured, large-scale reforms have been implemented to simplify and improve taxation, and a number of effective measures have been implemented to reduce the share of the shadow economy. measures have been taken.

Also, the system of rational use of budget funds was improved, the role and place of the Oliy Majlis in the budget process was increased, the powers of the representative bodies of local authorities were expanded, and the "Initiative budget" project was launched.In addition, sovereign international bonds of the Republic of Uzbekistan were issued, and the proceeds were directed to the financing of projects of strategic importance for the prosperity of the country.In accordance with the development strategy, priority is given to the task of ensuring the stability of the budget and external debt in Uzbekistan in 2022-2026. The reason is that the increase in the country's fiscal deficit and the increase in foreign debts

exceeding the standards set at the international level can certainly pose a threat to the national economy.

Also, this strategy envisages paying special attention to expanding the capabilities of local budgets in order to ensure effective spending of budget funds. In particular, special importance is attached to tasks related to further support of business activities, continuation of reforms on creation of business environment and necessary infrastructures, halving of poverty, development of regions and development of agrarian sector.
