Editorial

Welcome to our first newsletter of EUPHRESCO-2. This is our 'continuing' EU-funded Plant Health ERA-NET which started in January 2011 and which followed on from a successful EUPHRESCO-1 project from 2006-2010. In EUPHRESCO-1, we developed the mechanisms, tools and processes for doing transnational Plant Health research, as well as actually commissioning sixteen separate research projects using funds drawn from all 23 national research programmes involved.

EUPHRESCO-2 hopes to build on our past successes, but with an enlarged partnership. We hope that the research coordination and collaboration facilitated by EUPHRESCO can help meet the many challenges that we currently face in the area of Plant Health. We will emerge in 2014 as a long-term and self-sustainable network of Plant Health

EUPHRESCO Key Facts

- EUPHRESCO (European Phytosanitary Research Coordination) is an EU-funded ERA-NET
- It aims to better coordinate the funding of phytosanitary (statutory plant health) research at the European level in support of EU plant health policy
- EUPHRESCO-1 was funded by the EU 6th Framework Programme (FP6) from 2006-2010
- EUPHRESCO-2 is funded from the EU 7th Framework Programme (FP7) from 2011-2014
- EUPHRESCO-2 aims to be a self-sustainable network of European plant health research funders from 2014
- EUPHRESCO-2 involves a partnership of 31 leading organisations involved in funding or managing phytosanitary (quarantine/regulated Plant Health) research programmes in 22 European countries
- EUPHRESCO is a policy-led network. It has the support of the EU Council Working Party of Chief Officers of Plant Health Services. It also involves the European Commission's Directorate General for Health and Consumers (DG SANCO), the European and Mediterranean Plant Protection Organisation (EPPO) and the European Food Safety Authority (EFSA) through a Project Advisory Board.















EUPHRESCO-2 – Objectives

- To consolidate, develop and **deepen** activities that build on the successful cooperation between national plant health research programmes in EUPHRESCO-1, principally:
 - Transnational research projects that extend beyond just pilot projects
 - o Improved processes and tools for coordination, collaboration and communication.
- To **enlarge** the network to include additional partners both geographically and in terms of scope and commodity areas, e.g. an expansion of the representation of Forestry Plant Health and of players at a more regional level (e.g. Baltic/Nordic countries; Balkan and SE European countries), and outside Europe (more international linkages with third countries and trading partners).
- ❖ To test, refine and **strengthen** the model network structure and *modus operandi* such that a strong self-sustainable long-term network will emerge by the end of EUPHRESCO-2 in 2014.


EUPHRESCO-2 – Participants

The EUPHRESCO Network has expanded from 23 partners in 17 countries (2006-2010) to 31 partners in 22 countries with 12 European Observers and 2 international Observers. Its partners are leading organisations involved with funding phytosanitary research in Europe. See Page 4 for a full list of partners.

EUPHRESCO-2 – Launched

EUPHRESCO-2 was officially launched on 1st January 2011 and will run until April 2014. It aims to:

- Produce a strong, durable and self-sustainable network that fully incorporates existing and new members
- Coordinate national, transnational and EU funding for plant health research
- Implements joint, transnational research that best supports EU Plant Health policy (Community Plant Health Regime), operations (inspection services) and phytosanitary science capability





EUPHRESCO – Activities

Key Activities so far from EUPHRESCO-2

- ❖ EUPHRESCO-2 was launched on 1st January 2011
- EUPHRESCO's website was re-launched in 1st March 2011: it contains the key deliverables from EUPHRESCO-1, including information on completed and on-going transnational research projects, and information about EUPHRESCO-2
- The kick-off meeting and a workshop for new partners and observers were held in March 2011
- ❖ The selection of topics for the first round of transnational projects is near completion and the first projects are expected to start autumn 2011. We anticipate funding 10 separate projects at a total potential value of €2-3 million
- ❖ EUPHRESCO continues to advise on plant health research priorities for the EU 7th Framework Programme (2013 workprogramme) and Horizon 2010 (workprogrammes from 2014)

EUPHRESCO-2 – Integrating new and existing partners and observers

A kick-off meeting and one-day workshop was held to introduce existing and new partners and observers to themselves and to the project. The workshop was attended by 50 delegates from 27 different European countries and

was opened by Niels Gøtke from the Danish Science, Technology Agency for Innovation (DASTI). New partners gave introductory talks about their organisations, programmes and their expectations of being part of EUPHRESCO. Old partners spoke about the achievements of EUPHRESCO-1, lessons learnt and future ambitions for EUPHRESCO-2. Niels Gøtke closed the meeting stating that it had been a great success and had provided the new partners and observers with the opportunity to better understand the benefits of EUPHRESCO.



EUPHRESCO – Advising on Plant Health research in FP7



EUPHRESCO continues to advise the European Commission on plant health research priorities for its Framework Programme (FP7 and Horizon 2020). Most recently, this resulted in a plant health call, for the 2012 FP7 Workprogramme, entitled "Development of seed testing methods for pests and pathogens of plant health concern" (KBBE.2012.1.2-05). Other previous plant health projects in FP7 whose inclusion was specifically proposed by EUPHRESCO include: QBOL (DNA barcoding for plant health), Q-DETECT (tools for plant health inspectors) and the recently completed PRATIQUE Project (pest risk analysis techniques).
