1. Publishable summary

Summary description of project context and objectives

The overall aim of EUPHRESCO-II is to produce a strong, durable and self-sustainable network that: fully incorporates existing and new members; coordinates national, transnational and EU funding for plant health research; implements joint, transnational research that best supports EU plant health policy (Community Plant Health Regime), operations (inspection services) and phytosanitary science capability.

The main objectives of EUPHRESCO-II are as follows:

• To strengthen the basis for a self-sustainable network through the testing of a model network structure and modus operandi such that a strong and fully self-sustainable network will emerge after 2013 with a critical mass and network structure that ensures a permanent dialogue and cooperation between funders.

• To consolidate, develop and deepen current activities that build on the successful cooperation and collaboration between national plant health research programmes in the first EUPHRESCO Project. This would be done through the following: improved process, platforms and linkages that are fit-for-purpose in the context of future self-sustainability; continued transnational research that further demonstrates and builds confidence in the mechanisms, processes, added value and benefits of transnational research for supporting Plant Health policy, operations (inspection services) and science; continued optimisation of limited (in many cases declining) national resources for plant health research.

• To enlarge the network to include additional partners, both geographically and in terms of scope and commodity areas, e.g. an expansion of the representation of Forestry Plant Health and of players at a more regional level (e.g. Baltic/Nordic countries; Balkan and SE European countries), and potentially outside Europe (more international linkages with third countries and trading partners).

Description of work performed and main results

• WP1: The project started on 1 January 2011; all contracts have been signed, the first payment has been received and all partners have been paid.

• WP1: The Project website was re-launched (www.euphresco.org) in January 2011.

• WP1: The first project meeting (kick-off meeting) was held on 24-25 March 2011 in Copenhagen. The first Project Management Group (PMG) meeting was held on 24-25 February 2011 and the second PMG Meeting was held on 23 March (the day before the kick-off meeting).

• WP1: The third project management group meeting was held on 28 September 2011 and the fourth on 16 February 2012 (the day after the second annual project meeting).

• WP1: The second annual project meeting was held on 14–15 February 2012 in Rome.

• WP1: The EU Council Working Party of Chief Officers of Plant Health Services (COPHS) met on the 6 and 7 June to discuss EUPHRESCO's future. A poster session detailing EUPHRESCO's achievements and transnational projects past, current and future was held.

• WP1: Initial ideas and plans for the final dissemination conference have been gathered.

• WP2: the network is being implemented. The modus operandi for the future long-term sustainable network and the common strategic agenda continue to be developed.

• WP2: Discussions about EPPO and/or DG SANCO providing some support for the long-term EUPHRESCO network have taken place.

• A 'special' workshop to develop the details of possible future governance of EUPHRESCO will

was held on 15 May 2012 at JKI in Braunschweig.

• WP3: The timetable and procedure for the second round (2012 round) of research initiation were established with assistance from PMG.

• WP3: EUPHRESCO partners, observers and advisors provided suggestions for research topics of the second round (2012 round) of research initiation through the newly developed online-tool on the EUPHRESCO homepage. Subsequently potential funders indicated a first prioritisation of research topics by joining topic suggestions using the online tool.

• WP4: Most EUPHRESCO partners have enlisted to collaborate in one or more of the task groups that will produce the deliverables; demonstrating commitment and interest.

• WP4: An internal workshop was organised to coincide with the second PMG meeting being held in Paris at the EPPO HQ at the end of September 2011. It primarily discussed issues relating to the use of the website as a platform.

• WP4: As previously reported, the WP4 description of work has been substantially revised and is included in this report. The revisions were agreed and finalised by the PMG as a number of the deliverables were seen to be duplicating work already carried out and some were deemed to be no longer urgent. The amendments focus on the facilitation of transnational cooperation to meet EUPHRESCO's main objective.

• WP5: A special workshop for new partners was held alongside the kick-off meeting. New partners have chosen mentors from the old EUPHRESCO-1 partners.

• WP5: Three further workshops have been held. One in Tallinn 1–2 December 2011, exploring regionalisation of specific plant health problems in the region of the Baltic Sea and Nordic countries. One in Vienna 17–18 January 2012, exploring EUPHRESCO partners mandates to fund forestry research and important forestry plant health threats and one in Sofia 28–29 February 2012, exploring regionalisation of specific plant health problems in the region of Balkan and Eastern Europe.

Expected final results and potential impacts

Expected results and potential impact

The main expected results and impacts are:

• A deeper collaboration through further transnational research commissioning through both national and EU funding (transnational research projects), facilitated by improved mechanisms, processes and tools.

• An enlarged collaboration and cooperation through an increased number of partners, and the formation of a long-term self-sustainable EUPHRESCO Network.

Strategic impact

The European added value of EUPHRESCO-II lies in supporting and enhancing the European research area that underpins the Community Plant Health Regime (CPHR). This Regime is currently being reviewed by the Commission and member states.

Impact on the Structure of the Phytosanitary Research Area

Prior to the first EUPHRESCO Project, there was no coordination of national plant health research programmes. This was despite plant health policy being determined at the EU level and the need to have policy underpinned by sound science. EUPHRESCO-II will have the following on-going or new impacts on EU-level structuring of the plant health research area:

• A continued systematic sharing of information between national programme funders/managers.

• The continued development of strategic research agendas based on shared priorities on which joint trans-national activities can be based.

• An effective coordination of national, trans-national and EU-funded research that ensures the optimal deployment and use of funds for plant health research.

• A strengthening of more regionally-based cooperation between countries with similar climates, plant species and problems, as well as including more EU border countries.

• A strengthening of cooperation and coordination of research on specific plant sectors, especially forest plant health that was previously under-represented.

• A strengthening of potential international cooperation with researchers (at the project level) or

national funders (at the programme level) in third countries that either face similar plant health problems, or are potential sources of quarantine pests for the EU.

• The continuing development of common, proven tools and instruments for initiating and delivering trans-national research projects.

• A proven model for a long-term, self-sustainable network that will facilitate a permanent dialogue between funders, key stakeholders and end-users of the research (a long-term, self-sustainable EUPHRESCO Network beyond 2014).

• EUPHRESCO-II will continue to identify and address barriers to trans-national research.

Impact on National Research Programmes and Science Programmes

EUPHRESCO-II will have significant impacts and benefits for existing and new national phytosanitary research programmes, phytosanitary science programmes/services and research providers, as follows:

• Optimisation of national programme funds by preventing duplication and by increasing funding power through the pooling of national resources to achieve best research results.

• Building national research capacity and scientific expertise through collaborative trans-national research projects.

• Contributing to the increased cooperation between diagnostic laboratories, national phytosanitary science programmes and inspection services through trans-national research and the sharing of research outputs.

• Encouraging and helping facilitate, where possible, the setting up of national phytosanitary research programmes in European countries where they do not currently exist. Impact on EU Plant Health Policy

• EUPHRESCO-II will more effectively provide customised and rapid answers to policy-makers.

• It will also provide tools for inspection services dealing with regulated and emerging pests, thereby enabling more effective implementation of policy.

• EUPHRESCO-II will also involve policy-makers (and other key stakeholders and end-users) more directly in the process of identifying and prioritising research needs.

Impact on EU Exports and Competitiveness

Improved research coordination will contribute to:

• Better trade facilitation by: helping to prevent the introduction and establishment of new pests and diseases in the EU; providing diagnostic tools to facilitate the export of plant material.

• Reducing the socio-economic impacts of quarantine plant pests by helping prevent their introduction and spread with the EU and Europe.
