

## **End User License Agreement (EULA) SR-CACO-2 Dataset**

By signing this document, the user who will make use of the dataset agrees to the following terms.

With dataset, we denote all images, tiles, and patches.

### **1. Academic, non-commercial and not-for-profit use**

The SR-CACO-2 dataset is provided under the terms of this license strictly for academic, non-commercial, not-for-profit purposes. The user should not use the database for any non-research purpose(s). Non-research purposes include, but are not limited to:

- proving the efficiency of commercial systems
- training or testing of commercial systems
- using screenshots of images from the dataset in advertisements
- selling data from the dataset
- creating military applications
- developing governmental systems used in public spaces

### **2. Responsibility**

This document must be signed by an academic, i.e., a person with a permanent position at a research institute or university (the signee), e.g. a professor, but not a Post-Doc or a PhD/PG/UG student. Up to seven other researchers affiliated with the same institute for whom the signee is responsible may be named at the end of this document which will allow them to work with this dataset.

### **3. Distribution**

Redistribution, republishing, or dissemination of SR-CACO-2 in any form, source or binary, is not permitted without prior written approval by the licensor. The user may not distribute the dataset or portions thereof in any way, with the exception of using small portions of data for the exclusive purpose of clarifying academic publications or presentations. Note that publications will have to comply with the terms stated in article 5.

### **4. Further Rules**

The name of the licensor may not be used to endorse or promote products derived from this dataset and annotations without specific prior written permission.

The licensor reserves the right to modify the data/license at any point and to terminate access to the database at any point. Modification of the database by licensees is not permitted.

### **5. Publications**

Any publications arising from the use of SR-CACO-2, including but not limited to academic journal and conference publications, technical reports and manuals, as well as presentations for conferences or educational purposes, must cite the papers mentioned in the official SR-CACO-2 github page and are also stated in the email that provides details on how to access the database (sent by the licensor).

**6. Research**

The user may only use the dataset for research purposes.

**7. Warranty**

The dataset comes without any warranty. The licensor cannot be held accountable for any damage (physical, financial or otherwise) caused by the use of the dataset. The licensor will try to prevent any damage by keeping the database virus free.
