The new open call under this route opened in June 2024:

- Targeting National Level Initiatives
- Webinar to introduce support programme 8 May 2024 ([recording available](#))
- **Virtual clinics 18 and 20 June 2024** to answer questions from potential applicants
- **Deadline for applications: 12 July 2024**
- Notifications to applicants: end of July / early August 2024
- Start of support action: later September 2024

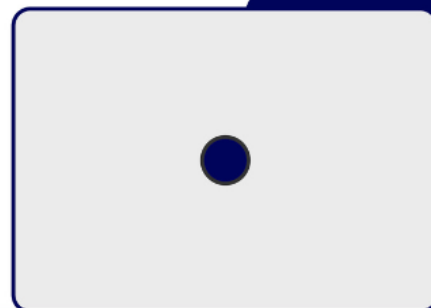

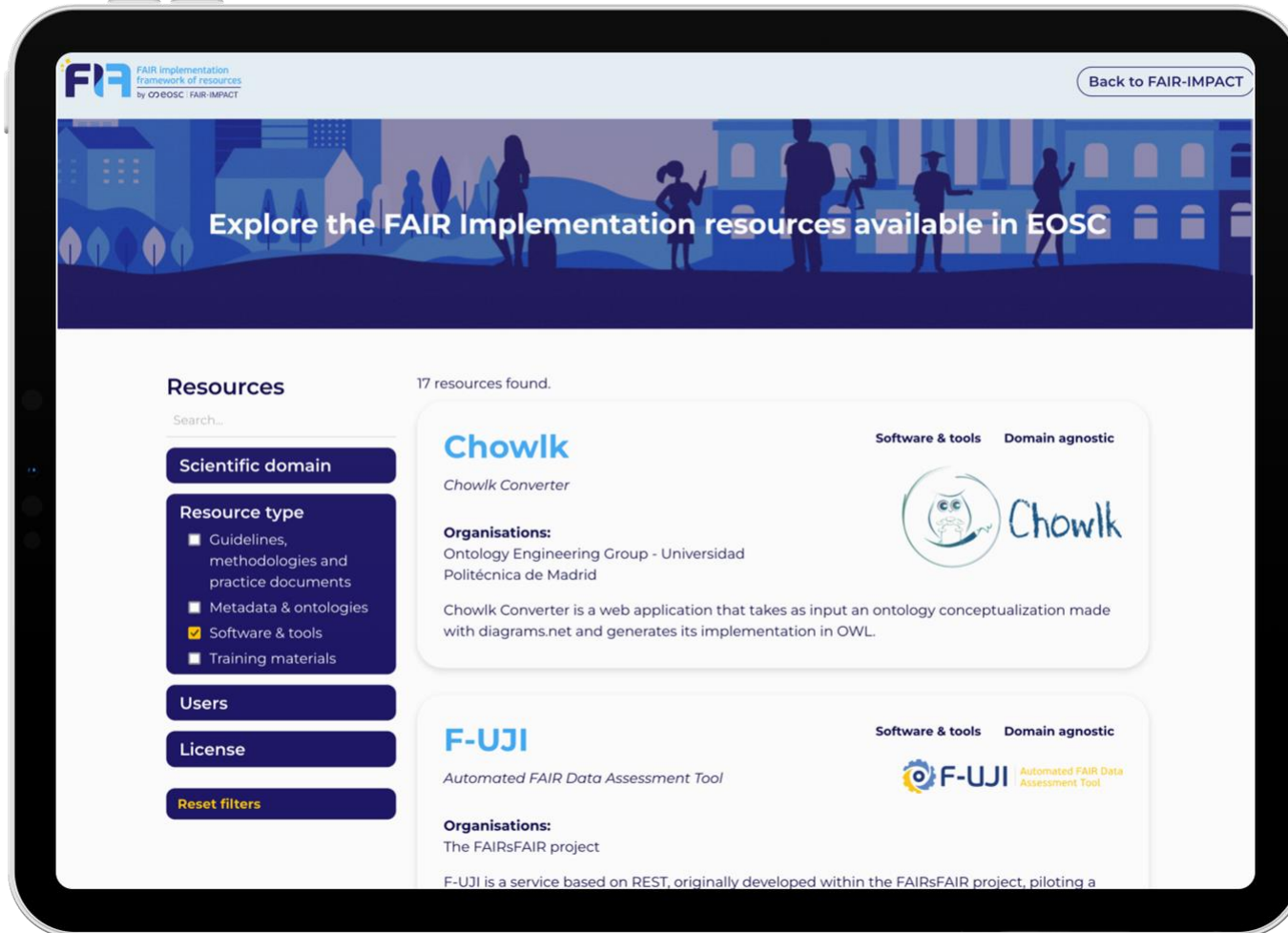

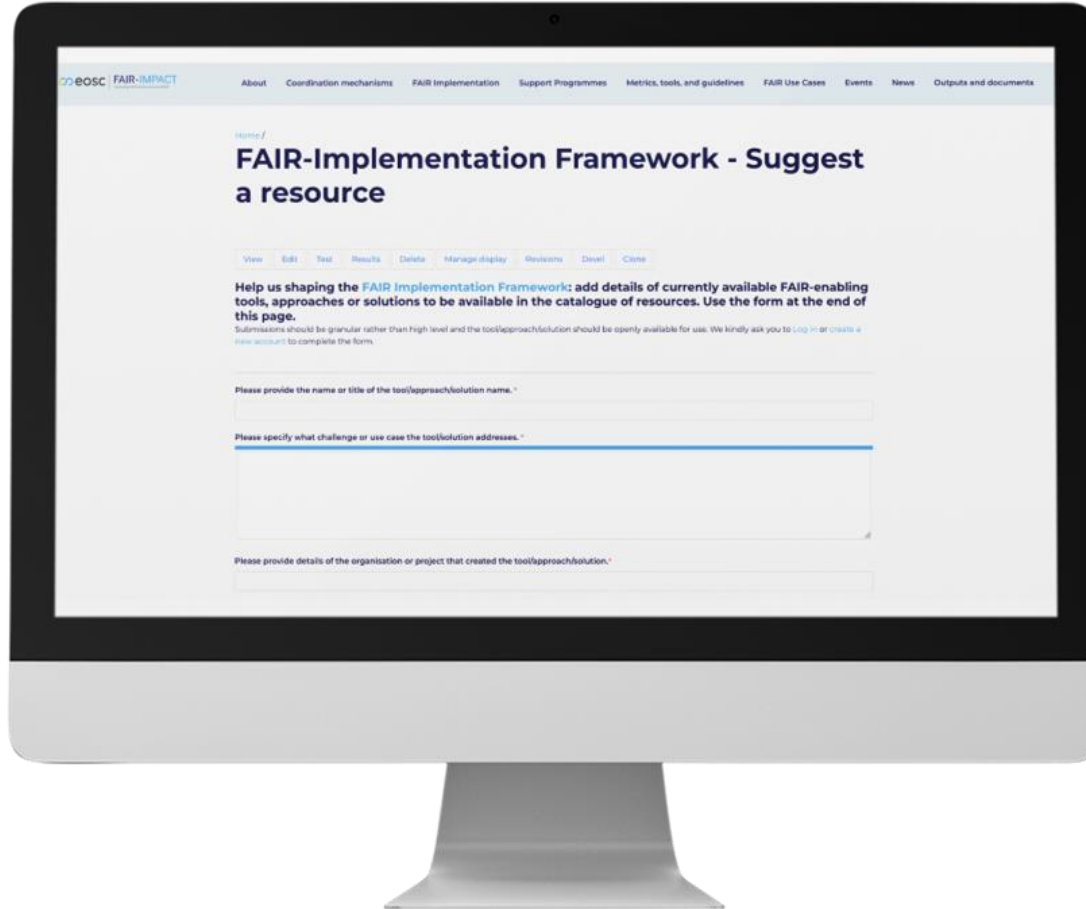
