This deliverable outlines the updated Terms of Service report (https://bioimage.io/docs/#/terms\_of\_service) that govern the use of the BioImage Model Zoo website (https://bioimage.io) and its underlying infrastructure, including hosted services such as the BioEngine, GitHub repositories, and continuous integration services. The Terms of Service sets out the general terms and conditions for accessing and using the website and services provided by the Al4Life consortium. It also includes detailed guidelines for submitting and sharing data and models, as well as prohibited uses of the site. The terms and conditions will be published on the project website. Users access or use of the project website or services constitute their consent to be bound by the Terms, as stated on the project website.

The report emphasizes the importance of legal compliance, intellectual property protection, and data privacy on the platform. It provides a clear and concise overview of the responsibilities of users and the rights and limitations of the Al4Life consortium in providing the services.
