

“Intertextuality in the Legal Papers of Karl Kraus. A Scholarly Digital Edition” (FWF project no. P 31138-G30)
- the historical situation:
 Karl Kraus and Oskar Samek in court

 8000 pages of legal documents in the Vienna City Library
- the base to build on:
 Karl Kraus Online
- the problem:
 text/collection vs. action, or: document vs. event



the historical situation

- Karl Kraus (1874 - 1936), Austrian satirist, writer and publisher
- Oskar Samek (1889 - 1959), his (main) lawyer since 1921/22 (other lawyers who worked for Kraus: Botho Laserstein, Willy Katz, Johann Turnovsky, Max Hirschberg, Felix Gallia)
- ca. 200 (court) cases in Austria, Germany, Czechoslovakia (Kraus both as claimant and as defendant)
- delicts in the areas of media law, copyright law, breach of contract, blackmail, threat, and defamation suits, ...

the material


- 4000 sheets of paper, collection today held at the Vienna City Library
- taken to exile by Oskar Samek where he started to prepare an edition of “Karl Kraus in court abroad” (unfinished)
- correspondences, newspaper articles, statements of claims, writs, verdicts, statements of costs, applications, requests, notes, ...
- material returned to Vienna in 1959, re-arranged by Katharina Prager in 2012ff, scanned and prepared for *Karl Kraus Online* (2017)

the base to build on

- an “anti-biographical” research platform (Prager 2017)
- three “roles” of the subject Karl Kraus:
The reader, the wrongly cited, **the legal subject**
- the data model:
“In order to enable this user-specific construction of the subject, it has to be broken down into its smallest units. For this purpose, four categories were defined as essential building blocks of life narratives: **events**, objects, individuals and institutions.”
(Hanneschläger/Prager 2015)

[41.] Josef Jelinek (vgl. Akt 40) brachte Friedrich Austerlitz und Karl Kraus noch weitere Erpressungen durch die Inseratenabteilung des Kronos-Verlages zur Kenntnis. So hatte Administrationsdirektor Forda auch das Bankhaus Kux, Bloch & Co. unter Druck gesetzt. Als dieses aber kein Inserat schaltete, wurde es in der Stunde wiederholt heftig angegriffen. Wiederum erstattete Kraus in Zusammenarbeit mit Friedrich Austerlitz und Oskar Samek Anzeige bei der Staatsanwaltschaft. Im Juli 1926 musste Békassy unter dem Druck der sich häufenden Vorwürfe und aufgrund einer ihm drohenden Anklage wegen Erpressung Wien (mehr oder weniger heimlich) verlassen.





... in the `<teiHeader>` of the collection,

but:

- in `<profileDesc>` in a *list* like `<listPerson>` in `<particDesc>`?
- in a random `<note>` ??
- in a `<text>`-element in `<teiCorpus>`, containing additional metadata (e.g. the short description of the case like in *Kraus Online*)?
- in `<sourceDesc>`, thus stating, that the event is the/a “source” of the collection?





how and where to encode the relations?

- TEI-XML represents relations primarily by nesting elements vs. relational data model of *Kraus Online*
- use `<relation>` and its special set of attributes `@active`, `@passive`, ... to express the linking between documents, events and entities?
- use an external taxonomy / maybe even ontology to classify relations?
- or: use “real” RDF in `<xenData>`?
