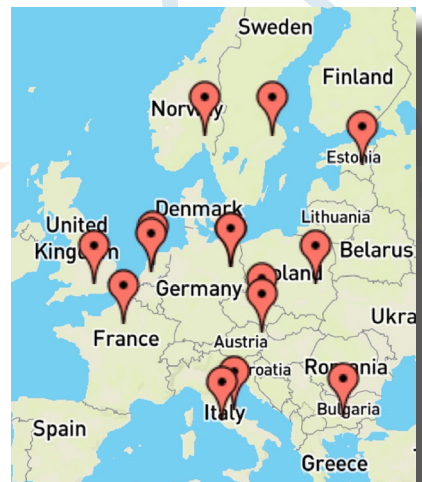

The One Health European Joint Programme (OHEJP) is reinforcing collaborations and integrating public health, animal health and environmental health in order to improve research on the prevention and control of foodborne zoonoses, antimicrobial resistance and emerging threats.

This OHEJP BIOPIGEE project is aiming to identify cost-effective biosecurity best practices which reduce the occurrence of Salmonella and Hepatitis E virus (HEV) in European pig farms and at slaughter. Thereby, important tools will be found to limit the pathogens' load along the food chain, leading to more safe and healthy animal-derived food.

This important research will create a benchmarking of biosecurity practice and consider different production stages of pigs in several European countries.
