#### **Executive summary**

Communication is an essential task of WP1 in ExPaNDS. Easy and effective accessibility of information regarding activities, the progress of milestones, the key roles of project members, the common agenda and the produced documentation and services is vital for the success of this project and will be beneficial to all.

This is achieved with the successful use and follow-up of the tools implemented on the project, hosted for the most part in the collaborative area.







#### 1 Introduction

This document presents the internal communication plan implemented in the ExPaNDS project to ensure seamless communication between work packages and towards the EC. It focuses on:

- · information needs,
- · specific roles,
- tools,
- communication with the EC.

This deliverable is complimented by D6.1 'Communication and Dissemination Plan', which provides high level objectives and organisation of internal plus external communication of the entire project.

#### 2 Information needs

The general needs for internal communication in ExPaNDS take three aspects:

- the **project** aspect with a need of information on general work progress and issues, centralized by the *Project Coordinator*,
- the **technical** aspect with a need for information on technical progress and choices, centralized by the *Technical Coordinator*,
- the need for input in order to accurately **disseminate** ExPaNDS activities, handled by WP6.

In order to identify and follow the specific needs of each WP, a dynamic table is shared with all Ex-PaNDS contributors.

The content of the *Information Requirements Table* is as follows:

- who is the **Beneficiary**, who requires the information,
- what input is required,
- Purpose, why this information is needed,
- at what Frequency,
- who is the **Provider** of the information,
- and finally what **Tools** are appropriate for this specific exchange.

### 3 Specific roles regarding communication

The individual roles are described in the ExPaNDS GA and in the Consortium Agreement. The specifics in relation to internal and EC communication are as follows:

- The *Project Coordinator* chairs the *Project Executive Board* and is responsible for all communications with the European Commission;
- The Technical Coordinator chairs the Technical Coordination Board;
- Work package leaders are responsible for all communication among their WP contributors as well as with their PaNOSC counterparts, and additionally:
  - WP6 is responsible for external communication and dissemination and for the tools used for internal ExPaNDS communication. In particular, the collaborative area is developed and maintained by WP6,
  - WP1 is responsible for ExPaNDS internal communication and the liaison to EOSC (EOSC structures in general and PaNOSC in particular), it administrates the 'sympa' mailing lists and chairs the EOSC liaison group. It also reminds the responsible partner ahead of time, when deliverables are due and follows-up the delivery progress.

In addition to individual roles, the four different boards (*Collaboration Board, Executive Board, Technical Coordination Board* and *EOSC Liaison Group*) are important channels within the ExPaNDS communication. To consolidate the collaboration with PaNOSC, the PaNOSC Project Coordinator takes part in Ex-PaNDS PEB videoconference. Similarly, the ExPaNDS *Project Coordinator* takes part in the PaNOSC management videoconference.

#### Who's who

Individual mail is also a mean of communication and two files are used to know who's doing what in the ExPaNDS project:

the stakeholders' list

It contains every person related to the project, with name, affiliate, E-mail, project, WP, role, ExPaNDS board membership, mailing list membership.

Each person is asked whether he/she agrees to be mentioned before appearing on the list. It can then be updated by each individual and is overviewed by WP1. It will then be stored in the collaborative area, with only project members getting access.

the project partners matrix

It confirms for ExPaNDS and for each WP the names of the WP lead, co-lead and contributor(s) per task.

It is updated by each WPL and the accuracy of this list is regularly verified by WP1 with the stakeholders.

#### **Documentation sharing**

In terms of documentation, the collaboration area contains, as a minimum:

- The list of deliverables and responsible partner for the deliverable review (which is by default the WP lead), updated by WP1. A picture of the table at the moment of this document's redaction can be found in appendix.
- The final version of the deliverables that are uploaded to the EC portal. They are the reference version of the deliverables to be used.
- The list of all presentations, publications and workshops running under the project name and being funded by the project.
- Any on-going working document that needs to be shared between several partners.

The need for specific working environments between the technical WP will be evaluated at later point in time.

#### Common agenda

A common calendar tool is provided in the collaborative area to share the project milestones, the board schedule and a list of other relevant events (workshop and conferences), which might be important for PaNOSC and ExPaNDS scientists (including information about registration deadlines).

#### Videoconferences

#### Software sharing

As stated in the GA, ExPaNDS will preferably use open source software in the delivery of its programme. This decision should increase the accessibility of the project and its services to users and in consequence increase the number of potential users and RIs able to participate; which in turn reflects the FAIR principles.

This includes the existing software used for project related deliverables (e.g. LibreOffice) and the specific developments that will be made for WP3 and WP4.

#### 5 Communication with the European Commission

The communication with the EC Project Officer consists mainly of:

- · periodic activity reports,
- submitting the project's deliverables,
- a mid-term review (around month 18) and a final review.
