

Why might you create a consortium?










US Government ORCID Consortium History

- Both a community need and anticipating future needs.
- DOE organizations, national laboratories, user facilities, and laboratory libraries had been collecting and using ORCID iDs to track research outputs and awards, determine the impact of user facilities, and evaluate the outcomes of outreach efforts. Many DOEaffiliated organizations were joining ORCID as individual members.
- ORCID researched out and asked about interest in starting an ORCID Consortium.
- DOE decided to create and offer membership in an ORCID Consortium to bring together and create a community around using ORCID iDs that also decreases membership costs across the complex, provides increased ORCID benefits and services, and offers streamlined administrative and technical support.
- Interest from other federal agencies led to the consortium membership being broadened to including other various federal agencies and organizations.

Consortium Lead Organization – DOE OSTI

Existing Internal Organization – DOE OSTI provides additional persistent identifier services for the DOE. DOE OSTI already provides DOI services for other federal agencies through a DataCite Consortium. History of providing government-wide resources through development and management of Science.gov.


Lead Responsibilities:








Community of Practice

- DOE OSTI leads the consortium Community of Practice (CoP).
- The CoP is open to any and all consortium members who are interested in participating.
- CoP calls every other month open to all members. Planning for future webinars, trainings, and workshops for consortium members.
- We share best practices, use cases, discuss challenges, raise ORCID awareness, share ORCID integration ideas, identify potential collaborations, and can offer benchmarking to consortium members.

What resources are needed to launch a consortium?

Website – need somewhere to point prospective members and existing members.



Documentation – started with Operating Parameters describing the Consortium details – background, membership features, Consortium Lead responsibilities, membership criteria, and membership fees. Developing addition resources – guide for researchers, OSTI's ORCID integration guide, adding works to ORCID record.

Community – developing a community of practice was key for the Consortium. US Government members often have unique integrations, questions, and challenges.

Development & Operation Challenges

- Finding 5 members and getting paperwork in place to launch the Consortium
- Transitioning current ORCID members to Consortium membership
- Navigating technical support provided by Consortium vs. provided by ORCID
- Balance of providing an optional service for those interested (US government agencies do not have to join the Consortium)
- Providing services for members without in-house technical expertise
