




Where we come from: progress report from the Netherlands



Quantity to Quality

- The 100% OA goal for 2020 was not reached
- Quantitative goal difficult to reach (long tail publishers, non-corresponding authors, costs)
- Late 2020 a feasibility study was commissioned by the Association of Universities in the Netherlands (VSNU) on how to achieve the 100%
- This creates an opportunity and necessity to look further and to reflect



Getting practical: broadening and deepening



Krachtige vervolgaanpak noodzakelijk

Onze inzet voor open access publiceren resulteert in een stijgende lijn. Dat is hoopvol, maar een krachtige aanpak is hard nodig voor de resterende stappen naar de 100% ambitie. Dit vereist een bredere dan wel nationale aanpak met sterke facilitering vanuit OCW/de minister (wet- en regelgeving, financiële stromen) en eventueel via NPOS. Dit moet er uiteindelijk in resulteren dat alle wetenschappelijke output voor iedereen, direct (zonder embargo) toegankelijk en (her)bruikbaar is. Gezien de afhankelijkheid van een groot aantal factoren kiezen we voor een gevarieerde aanpak die rekening houdt met de pluriforme publicatiecultuur, de grote diversiteit aan type instellingen, de internationale verschillen in op access beleid en de grote verschillen tussen uitgevers. En dat wetenschappers meerdere wegen hebben om hun onderzoek te delen.

“This should ultimately result in all scientific output being directly (without embargo) accessible and (re)usable for everyone.”

discuss metadata & licenses in negotiations



retrospective open access




OA for books/chapters/textbooks


