D-JRP15- FED-AMR -WP1.4: Webinars

Preliminary remarks

The deliverable **D-JRP15-FED-AMR-WP1.4** Webinars (T1.2) corresponds to the task **JRP15-R2-WP1-T1.2**. The teleconferences, comprised in the associated task, take place on a monthly basis, which is more often than initially proposed. The project partners decided this in order to facilitate interaction and discussion hindered by the different local restrictions due to CoV-2 of the collaborators. Some partners were unable to start laboratory work at the time points planned and others had to prioritise their contribution to SARS-CoV-2 testing and management for their institutions and the local government. Therefore, it was decided that the webinars should start at a later time point (M31)

Description of action

The organisation of the webinars was started in M25 in order to initiate knowledge transfer and for the project partners to have an accessible platform for in depth scientific discussion. The task leader, Mónica Oleastro (36-INSA), initiated a discussion about the upcoming webinar topics in the preceding teleconference starting with M30. All members of the consortium were asked for their input and recommendations concerning suitable speakers and other topic pitches. As deputy lead, the 2-AGES team, contacted the suggested speakers and fixed a date for the webinar with them. The task leader discussed the webinars scientific content with the speakers and transferred this information to the AGES team in order for them to prepare a suitable platform for the webinar. Together INSA and AGES appointed a chair and moderator, organised and implemented the webinars via Zoom. The agenda was distributed to all partners along with the official invitation to the webinar. AGES recorded, cut and uploaded the webinar files to the internal website for future reference. This was especially beneficial for consortium members that were unable to attend the webinars. For documentation purposes AGES also maintains a list of participants for each webinar and a list of suggested topics and speakers.

Description of the deliverable

The task **JRP15-R2-WP1-T1.2** lead by Mónica Oleastro (36-INSA) and Markus Wögerbauer (2-AGES), includes the organisation of webinars to facilitate scientific dialogue within the consortium as part of the deliverable **D-JRP15-FED-AMR-WP1.4**. The webinars were intended as a tool to establish and facilitate inter-consortium communication, scientific discourse and knowledge transfer between the partaking experts and partners. The agenda and the participant list attending to the first webinar are included in Annex 1 and 2 to this deliverable, respectively.

Confidentiality of the documents

The recordings of the webinars are available only for consultation of the consortium members. There were no arrangements made with the speakers about distribution outside of the consortium.
