

## Exploring Magneto-Meteorology with Ultra-Hot Jupiters Phase Curves from TESS

- Phase curves for ultra-hot Jupiters are shaped both by the hydrodynamic forces that usually act in planetary atmospheres but also by the planet's magnetic fields, giving rise to a new phenomenon magneteorology.
- Magneteorological effects can inhibit equatorial jets, driving the hottest (and brightest) point in the atmosphere westward of the sub-stellar point. • Competition between magnetic and hydrodynamic forces can results in phase curve oscillations that may be seen in data from the Kepler and TESS missions.

Planetary magnetic fields can shape phase curves and drive variability.



Preliminary analysis of the Kepler-13A b TESS observations show hints of phase curve variability.



Phase curves for ultra-hot Jupiters show significant variability over tens of days.

Exoplanetary phase curves, light reflected and emitted by the planet as it orbits its star, have revealed exotic weather on these distant worlds. Blistering temperatures on the cloudless daysides of ultra-hot Jupiters partially ionize the atmospheres, allowing them to feel the planets' magnetic fields. Eddy transport of angular momentum within the atmosphere can produce an equatorial jet, while magnetic stresses contribute retrograde accelerations. The competition between these forces can drive the hottest region in the atmosphere back and forth across the sub-stellar point, producing an oscillatory phase curve for some planets.

(a) Synthetic photometric time-series to replicate Kepler-13A b (blue dots) including the planet's transit, a hypothetical sinusoidal variability intended to replicate stellar variability, and Gaussian noise. The orange line shows this sinusoidal signal (with an amplitude  $A_{\rm star}$ ). (b) Transit depths T vs. stellar signal, both averaged over a 40-days. The negative slope *m* is consistent with expectations -- the brighter the star, the smaller the transit depth. This result suggests we can use variability in the transit depth to avoid mis-attributing variations in the phase curve amplitude to variability from the planet. (c) Transit depth-stellar signal slope divided by its uncertainty vs. stellar signal amplitude. This result suggests that stellar variability large enough to obscure the planet's phase curve would be detectable in the transit depth as well. (d) Kepler-13A b's orbit-by-orbit transit depth, with transit depth reported in Wong et al. (2021) shown by dashed, orange lines. Although there is apparent variability, all but one depth is consistent to within 4-

## Kepler-13A b may be an ideal candidate to analyze for phase curve variability.

Discovered and confirmed among the first several Kepler candidates (Faigler & Mazeh 2011, Shporer et al. 2011), Kepler-13A b is a nearly 10-Jupiter mass object in a 1.8-day orbit around a 7700-K, 9.95-magnitude A-star. With a dayside temperature approaching 2800 K and a radius about twice Jupiter's, the object induces a very deep transit and high signal-to-noise phase curve and ellipsoidal variation signals in both Kepler and TESS data. This high SNR makes Kepler-13A b an ideal candidate to search for variability.
