Summary

The Joint Integrative Project (JIP) “MATRIX: Connecting dimensions in One-Health surveillance” aims at strengthening the practice of surveillance along the whole surveillance process, from implementation to output. To advance in the implementation of One Health Surveillance (OHS) in practice, MATRIX is building on existing resources, adding value to them and creating synergies across sectors. The solutions proposed in MATRIX address the need of using a problem-based approach that solves real-life cases and the understanding of the different realities in each country considering the financial and infrastructural conditions.

Within MATRIX WP5 one of the goals was to develop a web-based Knowledge-Integration Platform (KIP) that supports knowledge exchange between different MATRIX partners and stakeholders. It should offer resources (e.g., tools/technologies/features) and permanent access to project outcomes. The KIP therefore aims at establishing a high-level framework that provides users with guidance and resources, e.g., technical solutions or guidance documents. To create the KIP, it was decided to extend the One Health Surveillance (OHS) Codex that was developed in the OHEJP ORION project (<https://oh-surveillance-codex.readthedocs.io/en/latest/>). To reflect the extension of the OHS Codex through the MATRIX project, we decided to rename the webpage to “OHS Codex: The Knowledge Integration Platform”; in the following we will refer to the KIP as OHS Codex / KIP. After joining the ORION and MATRIX efforts, the scope and purpose of OHS Codex have been updated to support surveillance design, planning and management phase.

The OHS Codex / KIP is designed as an open community framework and is available online via the following link: <https://oh-surveillance-codex.readthedocs.io/en/latest/>. The OHS Codex / KIP is also envisioned as a living resource that will be continuously updated. Everybody is invited to make suggestions on how to extend the OHS Codex / KIP. A OHS Codex / KIP curation board decides on the individual suggestions and implement changes into the OHS Codex / KIP system.
