# The DARIAH ELDAH consent form wizard (CFW)

- project implemented in 2020-2021
- co-funded by <u>DARIAH-EU</u>, <u>CLARIAH-AT</u> and <u>DARIAH-HR</u>

### What is the CFW?

An intuitive tool that enables DH scholars & the research infrastructure community to quickly and easily obtain standardized consent forms that conform to the GDPR.

- gathering data and/or consent from participants as the host of an academic event

# **CFW Tool**

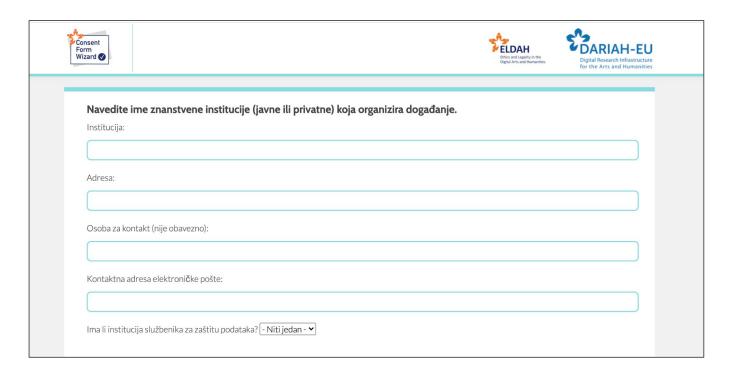
