DATA FILES

RAW SURVEY DATA

The survey data is either available as a '.sav' file, compatible with SPSS and other statistical tools, or as '.csv' for maximum compatibility. The .csv file format was chosen to make the data as openly accessible as possible, since both XLSX (Excel) as well as SAV (SPSS) files are not standard open data formats and require specialised or paid software to open and process. Both versions hold the same data.

While the SAV version can simply be opened in compatible software, the CSV variant is made up of two files:

- GRRIP_stakeholder_survey_data_CSV.csv from heron referred to as the "survey data"
- **GRRIP_stakeholder_survey_structure.csv** from heron referred to as the "survey coding structure"

The survey data file contains all questions and data of the survey, including qualitative data. Each column has a unique variable name header that is reflected in the survey coding structure. The properties of each file are as follows:

- Short but descriptive column names
- Initial column providing Unique IDs for each survey entry
- Survey responses coded as numeric values (except for open ended responses)
- Includes all survey questions, including open ended and "other" responses
- Only includes valid responses, i.e., test responses and responses with extremely low completion rates have been removed
- Fully anonymised

The accompanying survey coding structure file lists all variables of the survey data file and how the numerical values are coded (e.g., "1" = "Yes"). The survey coding structure file lists 3 layers of variable grouping depth:

• Variable Group


O Variables referring to the same question are grouped through a shared variable group name. For example, multiple choice questions have a unique column (variable) within the survey data file for each option, since an arbitrary number and combination may be presented. All columns of a given multiple choice question share the same variable group.

• Variable

 The variable name used in the survey data file to uniquely identify each data column. Variable names may repeat to group all response options to a single question. For example, the different options of a radio (single choice) question are coded starting from 1. Each numerical value is matched to its label by repeating the variable the required number of times within the survey coding structure file.

• Variable Options

 Each Variable may have an arbitrary number of options, such as the different numerical values of a single choice question, or the "Prefer not to say" checkbox of an open-ended question. Variable options cascade from variables and are unique across the entire survey coding structure file.



The above graphic illustrates the hierarchical structure, cascading down from "Variable Group" to "Variable" to "Variable Options". This structure can be easily converted to a dictionary type object, like a JSON file, while maintaining readability and ease of use of a standard tabular format. Further columns within the survey data structure file are:

Ouestion

 Simply lists the question relating to each response option, down to the variable options level.

Type

o Identifies the type of each question, such as "radio" (single choice), "multiple choice", "text", "integer", etc.

Label and Values

 Label and values are directly related, where label is the text value of the numerical value (values), e.g., "-97" -> "Prefer not to say"

VARIABLE NAMING CONVENTION

All variable groups, variables and variable options follow a common naming convention. Variable groups are always suffixed with a "_G". Variable options are always identical to their corresponding variable name, suffixed with "_OX", where X is an incrementing number counting the number of options for each variable. In some cases, variable options may seem redundant where a variable might only have a single option. However, the naming convention was strictly followed to avoid inconsistencies across the survey coding structure file.

• Example:

- o Variable Group: *education_G*
- Variable: education_arts_and_humanities
- o Variable Option: education_arts_and_humanities_O1

VARIABLE TYPES

The "Type" column of the survey coding structure file specifies the type of each variable as follows:

- **Text:** Simple text string for open ended questions or "other" responses. This is also used for nationality or country, where the number of possible items is extremely large. These are instead encoded as text (e.g., using ISO format for countries such as IE for Ireland).
- Radio: Single choice responses.
- Multiple Choice: Multiple choice responses.
- **Checkbox:** Checkbox style items, reserved for "Prefer not to say" (-97) toggles of openended text and number fields.
- **Integer:** Whole number responses
- **Likert Scale:** Likert scale responses. These are virtually identical to radio, or single choice responses.
- Likert Scale (Reverse): Reverse coded Likert scale responses, where the high value (e.g., 7 "Strongly Agree") would indicate a difference to the desired or "good" response. Example: "Not every human needs to eat" -> "Strongly Agree"
- **Semantic Differential:** Semantic differential questions are answered on a scale (in this case 7 points: -3 to 3). At each end of the scale an adjective is shown, and the respondent selects the point on the scale closest to how they feel/think. Contrary to traditional Likert Scales, only the outer most values have a label (i.e., -3 and 3). This variable type is therefore similar to the integer type, as any value from -3 to 3 may be found, where -3 always refers to the left (usually negative) and 3 to the right (usually positive) end of the scale. **Example:** For the scale [Unimportant Important] -3 would mean "Unimportant" and 3 "Important". Responses from -2 to 2 would gradually represent a higher/lower perceived level of importance.
