Background – FREYA project

Early 2020

- FREYA project commissioned scoping study investigating "PID Federation"
- Understand appetite for a coordinating initiative to help ensure sustainability of PID infrastructures



Research Findings

- Conducted interviews, questionnaires, followed by focus groups
- Interviews and questionnaires found idea broadly welcomed but with caveats
- Low overhead, but should have enough resources for meaningful action
- Focus groups prioritised three themes: Inclusion, Communication and Interoperability



Report Recommendations

- Conduct further, broader consultation
- Fully understand appetite for an organisation
- Define what exact solution should be
- Had to happen after end of FREYA project

PID Alliance (after FREYA project end)

Early- mid 2021

- Presentation at PIDapaloooza 2021 conference
- Call for interest in investigating this work
- Now group of c. 20 internationally supporting this work
- Aiming to secure funding to support further scoping
- Problem statement focusing on improving access to PID services internationally
- Presented idea to a range of funders

What do we want to do? (1)

Interim (before we secure funding)

- Series of events this is the first one
 - Asia, Latin America and Africa
- Improve understanding of PID landscape and barriers/challenges to access infrastructures
- Help to understand regional variation and local needs

What do we want to do? (2)

Funded activities

- In-depth interviews across the world, working with local colleagues
- Work in several languages
- A round-table event to communicate and refine recommendations
- Determine the need and scope and concrete actions to improve access to PID Services





- Conduct event series hopefully conclude mid-2022
- Secure funding for further scoping work
