1	Would you say that population decline, and economic stagnation are, in fact, producing challenges
1	for local governments in rural areas?
	Yes
1.1	What kinds of challenges are particularly significant?
	A first dynamic related to depopulation trends is the decrease of residing population, which entails a constant ageing process of those who remain. A consequence of the ageing process is that local governments must increase the social services they provide. Providing more and complex services in scattered municipalities is a major challenge they have to face, especially in terms of costs. Moreover, there is another challenge at administrative level: the Italian law regulates the fundamental functions each local government has to fulfil disregarding their size and localisation. Therefore, lots of small municipalities have to carry out unneeded functions (for instance having at least one policeman) while other much more needed services (social services) are lacking and difficult to implement.  The envisioned solution to these challenges has been to impose an associated management of key functions among different municipalities. Such logic is detached from the local reality: in scattered municipalities to manage a service together instead of saving costs could turn out to be even more expensive.  Ultimately, without the provision of services these localities become unattractive.

#### Urban Areas

4	What are some of the main growth-related challenges that urban local governments in Italy face?	
	The main challenges are, on the one hand, the increasing population density, and, on the other the phenomenon of commuting. These two intertwined dynamics can generate social inequalities also terms of taxation.  If for urban areas we do consider the metropolitan city (città metropolitana), few more challenge he to be considered. First, the problem of the adequacy (adeguatezza), namely the ability of the administration to carry out the tasks and functions entrusted to it by law. Secondly, the reform incompletion which entails a third challenge as for the democratic representation. The mayor of the chief city is automatically the mayor of the metropolitan city, a condition that does not protect the interests of other smaller municipalities.

	I suggested in a short article I wrote that a good starting point could be to allow the regions to distribute the national funds for the municipalities' mergers. The regions are already doing that for the union of municipalities and the mountain communities. Of course, such reasoning entails various difficulties on the juridical level, but it could be a starting point to differentiate these instruments according to the territory.
