(Auyang,1999) Holistic aims for the well-being of all human beings, in all of their dimensions. As a result, holistic must consider all facets of human beings, including spiritual, mental, and physical. Holistic therapy aims to rebalance and harmonize human beings' individual and social components. As a result, there is no split or duality in holistic thinking.)

The term holistic refers to a philosophical approach to the study of living things in psychology. Holistic thinking, in contrast to elementarism and atomism, leads to complicated phenomena that are impossible to explain without a thorough analysis. Holistic refers to the overall development of all pupils' potentials in order to establish harmony from an educational standpoint. (2010, Reber) Different sorts of potential include emotional potential (emotional), intellectual potential (intellectual), physical potential (physical), social potential (social), religious potential (spiritual), and aesthetic potential (aesthetics) (aesthetics). And each of these potentials must be nurtured in concert so that students' intellectual abilities grow in ways that go beyond the development of attitudes and skills. Miller (Miller,2021)

Holistic learning promotes the development of a comprehensive and broad mind by internalizing local and national greatness and wisdom. Holistic learning is a style of learning that emphasizes comprehending the content and relating it to other topics in order to build a knowledge foundation. Holistic learning is founded on the premise that if all aspects of a child's existence (mind, body, and spirit) are incorporated in the learning process, they will learn more effectively (Universitas Sanata Dharma,2009).

According to this definition, holistic education is a student-centered educational system that is based on communicative assumptions, is comprehensive, and considers students' and instructors' entire identities. (Haryanto & Rubiyanto, 2010) As a result, holistic is a strategy for achieving certain objectives. Learning techniques are particular talents that a teacher acquires and repeats, resulting in a pattern of teaching behavior that attempts to help pupils achieve instructional goals. Since each instructional content and objectives are different, students must prepare for different types of activities.

### **Learning Strategy Models**

The term "strategic" refers to a plan that outlines how to attain a specific goal. Strategy is the process of formulating top executive plans that focus on the organization's long-term goals, as well as the development of tactics or attempts to attain these goals. (Umar et al., 2001). According to Sanjaya, there are several types of learning strategies: expository learning strategies, inquiry learning strategies, problem-based learning strategies, thinking ability improvement learning strategies, cooperative learning strategies, contextual learning strategies, and affective learning strategies. Learning strategies are actions that teachers and students must engage in in order to achieve learning objectives effectively and efficiently (Sanjaya,2006). A learning strategy is a teaching and learning activity that must be completed by both teachers and students in order for learning objectives to be met.

According to Pohan, there are additional online learning approaches. Online learning may be regarded as a teaching and learning process because it can be done without needing to meet face to face. Online learning is one sort of distance learning media that takes advantage of its ease. Online learning is a distributed and open teaching and learning system that use pedagogical tools (educational tools) made possible by online and network-based technologies to aid the learning process and knowledge formation ( Pohan,2020).

### **The impact of the decline in interaction between lecturers and students**

The spread of Covid-19 has increased the awareness of the Indonesian people towards education. Because of its rapid spread, it even shocked the whole world. Online learning is used in Indonesia to maintain the smooth teaching and learning process. Given the current situation, online learning can be very useful in helping the learning process during a pandemic. Of course, doing online

The low level of student adjustment is caused because students have not been able to adapt to new situations and conditions. Regarding online learning, students are not optimal in their emotions. This is because online learning has an impact on students, such as confusion and stress, less creative and productive, passive, and lack of information(Argaheni,2020).So students have difficulty adjusting. The adaptation process for each individual is needed in order to face various demands from within and the environment to maintain a balance between meeting the needs and demands of the environment (Ghufron,& Risnawita,2017).This process can be demonstrated by the inability to control emotions and difficulty in dealing with changes when entering old age, negative thinking, stress, and conflicts in life, so that students can adjust themselves in dealing with current crisis conditions. Therefore, during the new normal, many students will experience difficulties in adjusting to new things in accordance with the policies implemented.

The availability of online learning platforms is also beneficial for the education community. According to Rusman, online learning offers several advantages, including: (1) Educators and students can easily communicate using internet-based devices at any time, regardless of distance, location, or time. (2) Educators and students can use internet-based teaching materials. (3) Since the teaching materials will be stored on the user's computer or mobile phone, students will be able to repeat the courses taught at any time. (4) If students need additional information, they can access the internet at any time. (5) Online exchange between educators and students can help students learn more. (6) Learners will be more independent and independent. (Rusman:2014) However, there are also weaknesses experienced by educators and students, namely: (1) Lack of interaction between students and other students as well as with educators. (2) There is a tendency to ignore academic or social aspects. (3) The role of educators has changed, which initially used conventional methods to become learning techniques using computers. (4) Students lack motivation in learning. (5) Not all online learning actors have internet facilities. (6) Lack of knowledge from educators in using internet facilities.

The use of the zoom meeting application which is currently worldwide is the result of technological advances. Which of course can be felt and is very useful in today's online learning. Zoom meeting is one of the social media used in the world of education, ranging from children's education to adult education. Zoom Meetings are more commonly used in online meetings because of its many features and benefits.

Another advantage is that there is a host feature that can manage every aspect of the zoom meeting, including the participants. The host can remove participants, turn off the participant's microphone, adjust the screen zoom, use the record feature to record and save the learning videos that have been carried out. With the freedom in these settings, it can make it easier for teachers and students to participate in learning activities. The rest of the Zoom meeting also has a background change feature, where users can change the background as desired.

This understanding shows that online learning results in a decline in the quality of interaction between lecturers (teachers) and students (students). Interaction is a very significant learning process in the success of learning itself. Interaction is mutual action, relating, influencing; interrelationships. Interaction is a relationship between two systems that occur in such a way that they affect each others(Chaplin, 2011).The success of the teaching and learning process is determined by the quality of the interaction between lecturers (teachers) and students (students), but if only the dose teaches while the students do not respond, the interaction will die.

By using the "Holistic" learning method, the response to improving the quality of interaction between lecturers and students is carried out with various learning techniques from all angles. To get the best educational outcomes, a holistic approach focuses on complete teaching-learning scenarios and uses a variety of learning methodologies to suit the needs of students, teachers, and the

Supervision and evaluation, so that schools make assessment forms to measure indicators of program success, regarding the implementation of multiplying posters, displays, SOPs in strategic places for consistent application of character (Ruhaina,2019).

The use of Zoom meetings is increasingly popular in the midst of the current Covid-19 outbreak. While there are many benefits to online learning, it also has drawbacks. Integrity comes from the Latin word "integer" which means: (1) a firm commitment to upholding principles, avoiding corruption, and being the basis for one's own moral ideals. (2) A quality, trait, or state of being that denotes a coherent whole with the ability to radiate authority; honesty ( Darmayanti&Widyaiswara,2020).

In his research on integrity, Tadung concludes (1) Integrity is a picture of someone who has self-quality in all aspects of his life, according to Tadung's research. (2) Integrity of Holy Behavior in Creating Servants of God Who Do not Follow Lust, Live

As a result, in the online learning process, the integrity of lecturers and students is very important. According to Afroni's research, "Holistic Approach in Improving Arabic Learning," (Tadung,2020).

In addition, students can learn Arabic as a whole, learning environment with integrity, realizing personal integrity between individuals and society, focusing on learning, developing students according to their potential (Afroni,2022).

Teachers use two main tactics to support students' online self-study, according to Aprianto's research on "Mixed Learning Methods in Learning English," which shows that teachers use two basic strategies to facilitate online student self-study: (1) requiring students to do online practice. (2) motivate students to use the online learning component by emphasizing the importance of online learning and featuring accessible tools and applications ( Eko Aprianto:2018).

### CONCLUSION

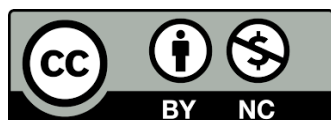
