4 incentives for taking action

#1: Technology and the diaspora

Citizens in and outside a conflict zone, as well as researchers and professionals from the cultural sector, join forces to take action, sometimes by just using their mobile phones.

#2: Forms of activism are present more than ever seen before in human history

An unprecedented spread of digital activism in support of social purposes (environment, social injustice, etc).
