


Multi-annual roadmap sets priority activities and outcomes grouped by three implementation levels – European, National, Institutional

#### Three phases of MAR

- 2021-2022: development towards a functional federation of infrastructure
- 2023-2024: expansion to production that generates added value
- 2025-2027: expansion to develop impact from Open Science









It recommends beginning with a first iteration to establish a Minimum Viable EOSC (MVE) addressing the needs of publicly funded researchers exploiting openly available data.









# EOSC Future project launched in April 2021



we will work with key stakeholders to ensure a smooth user experience, developing:

- **EOSC core**, the set of enabling services needed to operate the EOSC
- EOSC exchange registering resources and services from research infrastructures, other EOSC projects and <u>science clusters</u> to the EOSC and integrating them with the EOSC core functionalities
- the **EOSC interoperability framework** will provide guidelines for providers that want to integrate services or data into EOSC
