- The integral connection of education and upbringing, the orientation of this process to the formation of a person who has matured in all respects;
- Identifying talented young people, creating conditions for them to consistently receive fundamental and special education at the highest level of education.[7] Today, continuing education is understood as a process that includes formal, additional, distance, independent education. The main task of the library-information service is to create conditions for everyone's use of available resources, data and information for all directions of the continuous education system. According to the Strategy of Reforms, the successful implementation of huge changes in all spheres of public life largely depends on the level of legal consciousness and legal culture of people. - Non-availability of a healthy environment in the family, school, educational institutions, residences, places of recreation and entertainment;
- Inflow of literature, films, video products, newspapers, magazines and other sources of information that have a negative impact on legal socialization, promoting violence, moral corruption, criminal lifestyle, living at the expense of crime;
- Situations such as the inappropriate interference of state bodies, officials in the activities of education subjects, citizens' self-management bodies have a negative impact on legal socialization.

It is also necessary to note that the interagency public places of residence of the educational subjects participating in the process of legal socialization are not

clearly defined in the current laws, the personnel responsible for the organization of cooperation cannot meet the requirements of the time, the "people's guards", "border guards" working in cooperation with them lack of legal knowledge of public structures, lack of regular training sessions on legal socialization also have a negative effect. In the system of social institutions participating in the process of legal socialization, libraries have a special place in enriching and strengthening the legal knowledge acquired in the family, school, colleges, and higher educational institutions. Because the information service organized by the library in the so-called "person-to-person" direction of legal socialization of a person according to its work content is extremely important. In this place, the activities of libraries, which are carried out using various forms and methods, will be effective in the directions of formation and improvement of users' legal knowledge.
