In order for spiritual and educational events to be effective, it is necessary to follow the order of their organization, strengthen practical cooperation with the agencies and organizations responsible for organizing events and closely support their activities in this regard. Because conducting separate work gives less results, conducting spiritual-educational and educational work in cooperation has always yielded positive results, the need to act together in this regard has justified itself in practice. The need for systematic conduct and coordination of these works poses urgent tasks to those responsible for today's spiritual and educational process. Therefore, when organizing and conducting spiritual and educational events, it is necessary to take into account the specific characteristics of regions and neighborhoods, but also take into account the specific aspects of effective organization of events.

How is efficiency achieved in this process? The results of this process are achieved by providing comprehensive support to women in a difficult social situation, including women with disabilities, their children and their families. In the process of communicating with them, it is required to treat the citizen, his thoughts and values with respect, understanding and attention, to operate based on the possibilities of his potential and to regularly improve his skills.

This is an important factor in timely identification of the problems of women who need special attention, advising them, directing them to the relevant responsible offices and organizations (medical, legal, psychological, educational, etc.) and mobilizing their opportunities.

Working with women in a difficult social situation, including women with disabilities, in the process of studying their problems, problems and their root causes (internal, external factors causing the problem) and the internal possibilities of the family (positive, i.e. strengths), as well as the opportunity of exemplary families and citizens in the neighborhood, as well as the purposeful use of both opportunities, it is necessary to have the ability to work in cooperation with the family, its members and responsible organizations and agencies.

Based on the above, it is permissible to cite the following recommendations for improving the effectiveness of the women's activist in working with women in a difficult social situation, including women with disabilities:

- timely identification of the problems of women who have fallen into a serious social situation, including women with disabilities, by women's activists;
- record the results of the study in questionnaires and determine the level (category) of their need for social protection;
- formulating individual programs for targeted work with them and providing them with comprehensive support and carrying out specific goal-oriented work;
- to issue orders to the agencies and organizations responsible for social protection, to be able to put the issue to them correctly;
- to create conditions and opportunities for women's activists to regularly improve their knowledge of working with families and women who are in a difficult social situation, including women with disabilities, and to organize permanent working seminars for them;
- systematic one-on-one interviews with women who have fallen into a serious social situation, including women with disabilities, by women's activists, to have accurate information about whether the problems have been solved or not;
- providing comprehensive assistance to women in severe social situations, including women with disabilities, their children and their families, targeted use of the family's internal capabilities;

- it is appropriate to respect the dignity and values of every citizen, to work in close cooperation with exemplary families, responsible organizations and agencies in the neighborhood.

Women in a serious social situation, including women with disabilities, and their families should be under the constant attention and control of a women's activist, conducting targeted and systematic (practical) work with them individually, it is important that all responsible agencies and organizations responsible for supporting them and solving their problems to know their duties and social responsibilities in this regard. The results of the observations show that most of the conflicts in the family are related to unemployment and financial support. A woman who has a profession or trade can meet her material needs independently. In Muslim families, financial support is mainly a male responsibility. But if a woman also works, she will first find her place in society. She is happy to earn material income while devoting her time to the profession she loves. She works on herself, takes care of herself, does not get involved in the small details of life.

How important are women's rights in world politics? Events of various nature observed in different regions of the world today led to the embodiment of women in world politics not only as an active subject (in administration, peace maintenance, economic processes), but also as an important object of social relations. Also, as a result of poverty, internal conflicts, diseases, economic and political crises, the focus of economic, social and political relations on the issue of women has become a demand of the time.

Taking into account that 49.6% of the world's population is made up of 34 women, their comprehensive support has become an important factor in the economic development of countries. She emphasizes that issues such as the feminization of poverty, unemployment, the dire consequences of the environment and the participation of women in the processes of making important decisions should be given the most urgent importance.
