

# 1. Terms of Service Agreement

Welcome to BioImage.io! Our website, www.bioimage.io (the "Site") is owned and operated by the Al4Life consortium ("Al4Life"). By accessing or using the Site and related services (collectively, the "Services"), you ("you" or "User") agree to be legally bound by the following terms and conditions ("Terms of Service" or "Terms").

If you disagree with these Terms, you must not use the Site or Services. Please read these Terms carefully before using the Site or Services.

#### 1. General

Al4Life provides the Site and Services to Users who are 13 years of age or older. If you are not 13 years or older, you are not authorised to use the Site or Services.

Al4Life reserves the right to modify these Terms at any time. If changes to these Terms are made, BioImage will post the amended Terms on the Site. Your continued access or use of the Site or Services after such posting shall constitute your consent to be bound by the Terms, as amended.

### 2. Accessing the Site

- 2.1 Access to the site is permitted on a temporary basis, and Al4Life reserves the right to withdraw or amend any service it provides on the Site without notice. Al4Life will not be liable for any reason in the event that the Site or any Service is unavailable at any time or for any period.
- 2.2 From time to time, Al4Life may restrict access to some parts of the Site or the entire Site.

#### 3. All Website Submissions

- 3.1 By submitting any material or content to the website (hereinafter "User Content"), you represent, warrant, and covenant that:
  - (a) you have the legal right and authority to accept these terms of submission and to grant the applicable licence (as more particularly set out below);

- 3.2 By uploading or posting a submission or any User Content, you grant AI4Life a non-exclusive, worldwide, fully paid up and royalty-free, irrevocable, perpetual, and transferable license to use, copy, modify, adapt, publish, translate, create derivative works from, distribute, publicly perform, and publicly display such User Content.
- 3.3 Al4Life reserves the right to remove any submission or User Content at any time, for any reason, and without prior notice.
- 3.4 Al4Life will have the right to disclose your identity to any third party who claims that any material posted or uploaded by you to the site constitutes a violation of their intellectual property rights or their right to privacy.
- 3.5 Al4Life will not be responsible or liable to any third party for the content and accuracy of any materials posted, transmitted, uploaded, or submitted by you or any other user to the site. The User is obliged to hold harmless and indemnify Al4Life for any claim of any third party against them (including legal costs), caused by the User's use of the Site or User Content including but not limited to infringing intellectual property rights.

## 4. Prohibited Uses

- 4.1 You may use the site only for lawful purposes. In particular, you may not use the site:

- (f) to knowingly transmit any data or to send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware, or any other harmful programs or similar computer code designed to affect the operation of any computer software or hardware adversely.
- (g) use of the Site for commercial purposes is subject to the express written consent of AI4Life.

#### 4.2 You also agree:

- (a) not to reproduce, duplicate, copy, or re-sell any part of the Site in contravention of these terms;
- (b) not to access without authority, interfere with, damage, or disrupt:
  - (i) any part of this Site;
  - (ii) any equipment or network on which the Site is stored;
  - (iii) any software used in the provision of the Site; or
  - (iv) any equipment or network, or software owned by or used by any third party.
- 4.3 A breach of Clause 4.1(f) or 4.2(b) may constitute a criminal offence under the Computer Misuse Act 1990. Al4Life will report any such breach to the relevant law enforcement authorities, and it will cooperate with those authorities by disclosing your identity to them. In the event of such a breach, your right to use the Site will terminate immediately.

## 5. Intellectual Property.

- 5.1 The Site and Services contain content, including but not limited to text, graphics, data, images, videos, and other material ("Content"). This Content is owned by or licensed to Al4Life, and is protected by applicable intellectual property and national and international laws. All rights are reserved.
