

- United Nations Rights of Persons with Disabilities (2007)
- Paris Agreement (2016)



Where does **Accessibility** fit within the wider **Sustainability** agenda?



United Nations' 2030 Sustainable Development Goals (2015)

“

The 2030 Agenda for Sustainable Development is the world's globally agreed plan for peace and prosperity for all on a healthy planet. But this vision of a better future can only be achieved with the full participation of everyone, **including persons with disabilities**. Upholding the rights and ensuring the full inclusion of the world's billion persons with disabilities **is not only a moral imperative, but also a practical necessity**.

What are some of the specific concerns of people with disabilities?

- Access to emergency evacuation and facilities
- **Access to environmental information in alternative formats**
- Participation in climate mitigation planning and emergency preparedness

Example: Hurricanes Katrina and Rita (U.S. 2005)

- People with disabilities were:
 - Disproportionately affected by both hurricanes because their needs were overlooked.
 - Often unable to evacuate because transportation and evacuation shelters were inaccessible.
- **People with visual and hearing disabilities were unable to access important safety information because it was unavailable in alternative formats.**

Most references to disability and people with health conditions or chronic illness in States' climate adaptation policies are **cursory in nature**. In many policies, persons with disabilities are listed amongst other groups especially vulnerable to climate change impacts, but **without further detail as to the measures that should be taken to ensure the inclusivity of adaptation measures**.


