# EXECUTIVE SUMMARY




Fig. 1: Infographic: COPIM End-of-project highlights as of 04/2023

Right from its inception, COPIM has been committed to exploring solutions to some of the most pressing issues and problems that prevent small open access (OA) book publishers from interfacing with large-scale publishing infrastructures, organisations, and processes. This commitment is reflected in the major improvements COPIM has developed over the last 3.5 years in the form of a significantly enriched, not-for-profit, and open-source ecosystem for OA book publishing; an ecosystem that is now growing to help support and sustain a diversity of publishing initiatives and models, particularly within Humanities and Social Sciences (HSS) publishing.

The alternative infrastructures, business and revenue models, preservation structures, and governance procedures that have been scoped, developed, and proof-of-concept-delivered through COPIM, enable increased economic resilience and enhanced capacities for the publication and dissemination of open access books at a variety of scales. COPIM's *scaling small* approach<sup>1</sup> offers Higher Education institutions and HSS researchers sustainable publishing models that they control, providing them with increased publishing options, new revenue streams, and cost reductions that are designed to help build a more equitable, horizontal, and co-operative knowledge sharing community.

COPIM has used the project's final 18 months (including a no-cost extension of six months due to the coronavirus emergency) to successfully deliver in the areas of collaborative research, infrastructure development, governance work, and outreach and community building, while also contributing to policy consultations in an international context. Further evolving its approach to cope with the continued and compounding challenges that the COVID-19 pandemic, Brexit, the Russian invasion of Ukraine, a heat-or-eat crisis/recession, and UCU strikes for better pay, and further emerging issues on regional and global scales have posed to the Higher Education sector and beyond, the project has succeeded in meeting the vast majority of its deliverables and milestones across all work packages over

the last few months, in some areas even outperforming the initial goals set and superseding expectations.

The final list of key outputs and activities delivered across the project's lifespan include:

- **publication of 13 major scoping reports, 3 annual project reports**, plus a variety of **research papers published in peer-reviewed journals**;
- successful organisation and documentation of **26 workshops**, with **more than 220 national and international stakeholders representing 25 countries**.
- presentation of COPIM work at **more than 120 international conferences, workshops, and events**.
- set-up an iterative extension of an **Outreach and Dissemination network** that is combining a variety of channels, including social media and open community platforms.
- following the platform's beta launch in 2021, the successful inception of **Thoth**, COPIM's Open Dissemination System, as a Community Interest Company under the name of **Thoth Open Metadata CIC**. Thoth now makes **open access book metadata** available in an open, transparent, and participatory way via its open API, and publishers can use the platform's interface to create rich, open metadata for direct dissemination in a variety of global channels.
- launch of the **Open Book Collective** platform and community of OA book publishers, infrastructure providers, and libraries that are collaborating to bring about a future for OA book publishing free from inequitable Book Processing Charges. This included generating more than £100,000 in invoiced income to date, and over £14,000 of income expected to be invoiced shortly, 90% of which will flow either direct to OA book publishers and service providers or to the wider OA publishing ecosystem via our grant giving Collective Development Fund. It has also implemented a robust legal, financial, and governance model to ensure longer-term stability of the Open Book Collective legal entity which has been registered as a CCLG in the UK in 2022.
- further strengthening of the **Opening the Future** revenue model via the two publishers, CEU Press and Liverpool University Press, that COPIM has been working with. Through *Opening the Future*, both presses have released 15 new monographs between them, and have accrued enough funding through the programme for approximately 45 titles to be published OA in the coming months/years.

- launch of the **Experimental Publishing Compendium**, as a comprehensive online resource bringing together tools, practices, and books to promote and support the publication of experimental book publications.
- establishing the **Thoth Archiving Network**, a community-led collaboration between university repositories and national libraries to facilitate archiving and preservation of OA books via COPIM's Open Dissemination System *Thoth*, particularly those published by small and medium-sized publishers that might not have the resources to invest in other, more expensive means of archiving.

The COPIM project has continued and deepened its engagement with the work packages' variety of stakeholders (i.e., librarians, publishers, researchers, technology providers, and the general public), bringing together key experts and those interested in learning more about scholar-led, not-for-profit, OA book publishing. Alongside its own event organisation and outreach activities, COPIM has been involved in the [Open Access Book Network](#), while COPIM team members have participated in a wide range of conferences, events, and network events organised by partner organisations and projects such as [OASPA](#), [OPERAS](#), [LIBER](#), the [Next Generation Library Publishing project](#), [Invest in Open Infrastructure](#), [OpenAIRE](#), [The British Library](#), [COAR](#), [EIFL](#), [Open Access Australasia](#), and the [European Open Science Cloud](#).

The sustained progress against the original plan is particularly noteworthy as the project had to work with the continued and compounding effects of the various systemic challenges that COPIM has faced since its inception. As has been outlined in previous reports, Brexit and the COVID-19 pandemic – along with the systemic effects these events continue to have on the Higher Education sector as a whole – has impacted much of the project work on COPIM. The Russian invasion of Ukraine has added further volatility to the sector. As a result, the project has had to accommodate a variety of delays in staff recruitment along with an increase in pandemic-related limitations to the availability of staff members due to extended care duties and the toll on health and wellbeing of all involved.

In addition to that, library budgets have declined due to COVID-19 pandemic cuts in funding for HE institutions and library budgets. As per feedback received from librarians, many budgets have been reduced to 'essential spending only'. This has directly impacted the outreach conducted by WPs 2 and 3.

Despite these challenges COPIM has, together with its evolving network of stakeholders, now successfully implemented its open infrastructure proof-of-concepts together with the corresponding systems of governance that had been conceptualised over its first two years. The six-month no-cost extension that COPIM

requested from its funders to make effective use of the budget underspend accrued during the project's lifetime due to the above-mentioned systemic challenges, has proven fruitful and enabled the team to succeed in completing its work on the envisioned proof-of-concepts for an alternative ecosystem of open infrastructures for monographs.

## ANALYSIS OF PROGRESS AGAINST TIMETABLE: OVERVIEW

This report is the final of three annual reports to be submitted to [Arcadia](#) by the Community-Led Open Publication Infrastructures for Monographs (COPIM) project.

### Background

Right from its inception, COPIM has sought to transform OA book publishing by delivering major improvements in the infrastructures used both by OA book publishers and by those publishers making a transition to OA books. In view of that goal, COPIM has now successfully completed the development of several proof-of-concepts that serve as critical underlying modular components to support the sustainable publication of OA books. These involve/For example:

- **Infrastructures** (WP2 and 5), including a fully functional consortial library funding platform and community, the *Open Book Collective*, and an Open Dissemination System (ODS), *Thoth*, for the integration of OA books into discovery systems;
- **Business models** (WP2 and 3), including an online toolkit and two pilot cases with existing OA publishers and publishers seeking to transition to OA monographs via COPIM's *Opening the Future*;
- **Governance procedures** (WP4), including best practices for the governance of community-led open-source infrastructures and OA presses, and a co-designed and co-developed organisational governance model that has been fully implemented in the context of the *Open Book Collective*;
- **Experimental Publishing workflows and Re-use strategies** (WP6), to support the publication of experimental books and emergent genres of scholarship, and to promote OA book content discovery, interaction, and

reuse. These are now being made available via the WP's reports, pilot project documentation, and the *Experimental Publishing Compendium*;

- **Preservation structures** (WP7) for the archiving of complex OA books, which are now being implemented as part of the *Thoth Archiving Network* and accompanied by an extensive resource on good practice regarding the archiving and preservation of OA books;
- **Outreach programs** (all WPs) including extensive knowledge exchange activities with a range of HE and publishing stakeholder partners.

These systems and infrastructures have been envisioned from the start to be fully open, collectively managed for the common good, and to map onto existing publishing workflows (e.g., from publisher to library) while also re-engineering them.

As a result, COPIIM is proud to say that the team has now successfully released a set of proof-of-concepts that enable a significantly enriched, not-for-profit, and open-source ecosystem for OA book publishing that helps to support and sustain a diversity of publishing initiatives and models, particularly within HSS publishing.

## Achievements

During its last 18 months, the project has further developed its work on collaborative research, open infrastructures, governance, project management, and outreach. COPIIM's work packages have further increased its engagement with communities that have been approached during the first two years of the project, to synthesise the collected research data, building on the landscape studies and scoping reports that have been published, and the stakeholder workshops conducted. All of this has been carried out in preparation and support of the infrastructures, the pilot projects, and the governance and preservation structures that COPIIM had started to develop in Year 2, and finalised to live proof-of-concept status during Year 3. In parallel, the project has been developing its underlying philosophy and organisational principle of 'scaling small',<sup>2</sup> which has informed the project's overall activity throughout its lifespan, engaging the work packages in

active dialogue around how such a principle can be implemented and put into practice.

COPIM has already been able to successfully complete the vast majority<sup>3</sup> of the activities and outputs set out in its initial business plan and project proposal. The main results achieved at the end of the project include:

- **publication of thirteen major scoping and research reports**, including:

This also impacted the revenue generated by the Open Book Collective during the life of the project, which means that the revenue target of £150,000 by the end of the project was not fully achieved. However, the Open Book Collective has been able to reach that goal four weeks after submission of this report, successfully generating £150,944 in invoiced income from 25 libraries participating in the collective membership programme.

- The successful launch of the **Open Book Collective** – a platform and community of OA book publishers, infrastructure providers, and libraries that are collaborating to bring about a future for OA book publishing free from inequitable Book Processing Charges. The Open Book Collective has been registered as a CLG (company limited by guarantee) in the UK in 2022 – a not-for-profit – and is currently in the midst of applying for full charitable status with the UK Charity Commission.
- The successful **implementation of COPIM's [Opening the Future](#) model** whereby library members pay a small annual fee to have unlimited multi-user access to eBooks from the publishers' backlists, and the membership revenue is then used to produce new OA monographs. This programme is facilitating the transition of two publishers – [Central European University Press](#) and [Liverpool University Press](#) – toward OA-amenable business models. At the end of COPIM, the presses involved have already released 15 new monographs, and have accrued enough funding through the programme for approximately 45 titles between them to be published OA in the coming months/years.
- The organisation and documentation of **26 workshops overall**, through which COPIM has engaged with more than **220 national and international stakeholders** from the UK, US, Africa, Latin America, Australia, New Zealand, and Europe to establish communities of interest on a variety of overarching open access book-related topics;
- The development and successful launch of COPIM's Open Dissemination System under the name of **[Thoth Open Metadata](#)**. *Thoth* is a platform and service to make open access book metadata available in an open and transparent way. To date, 18 OA book publishers are making use of Thoth. As of 2022, Thoth Open Metadata is a Community Interest Company (CIC) registered in the UK;
- The setup and launch of the **[Thoth Archiving Network](#)**, a community-led initiative to create an easy-to-use dissemination system (building on the success of **Thoth**) for small publishers to archive their monographs in a network of participating institutional repositories;
- The setup and iterative extension of a set of **Outreach and Dissemination activities** that are combining a variety of channels including social media and open community platforms;
- The development of **three Pilot Projects of experimental books**, co-created with international communities of scholars, software and technology

providers, and three scholar-led presses, Open Humanities Press, Open Book Publishers, and Mattering Press.

- The development and successful launch of a **dedicated set of toolkits** to support publishers and the wider public with questions related to [archiving and preservation](#), [experimental publishing](#), the [implementation of an Opening the Future-esque business model](#), and a [toolkit for small and scholar-led presses](#).

The project has successfully fostered engagement with the work packages' variety of stakeholders (i.e., librarians, publishers, scholars, technology providers, and the general public), bringing together key experts along with those interested in learning more about scholar-led not-for-profit OA book publishing. In addition to the workshops organised by COPIM and participation at [more than 120 international conferences and events](#), the team has also supported and contributed to events and workshops held by external stakeholders and organisations aiming towards goals that are mutually beneficial (following the previously mentioned principle of *scaling small*). 


Fig. 2: Overview of COPIM's collaborations with international networks and projects (2019-23)

## Impact

During the last eighteen months, COPIM has built on the impact achieved across all work packages during its first two years, and has exceeded the set deliverables and milestones in most of its work packages. Engagement with key stakeholders (including publishers, knowledge managers, and librarians) from the UK, United States, Europe, Latin America, Africa, Australia, and New Zealand has been deepened. The many new connections established has meant that interest in COPIM's approach from external stakeholders is mirrored in the consistently high engagement numbers that are available from the list of outputs (see Appendix) generated by the project so far.

COPIM has also been generating impact on the level of national and international policy-making: COPIM team members have been consulted in the preparations towards the inception of UKRI's Open Access to Monographs policy via written statements, roundtable discussions, interviews, and dedicated multi-stakeholder workshops. The COPIM team's expertise has also been sought in a variety of other policy contexts, such as the [Making Mandates Reality](#) conference co-organised with RLUK in 2022, COPIM's participation in the 2022 event [A Plan S for Books? Voices from the Open Access Books Community](#) organised by the Open Access Book Network, and a 2023 roundtable discussion organised by German funder DFG.

Building on its well-established Outreach programme, COPIM's engagement with library stakeholders has continued to exceed the project's initial plan: *Opening the Future*, the business model devised to support traditional presses with transitioning towards an OA-amenable, non-BPC-based future, is seeing impressive uptake. Since it launched, two respected publishers, CEU Press and Liverpool University Press, have come on board and library membership uptake has now accrued enough funding between them to publish 45 OA monographs over the coming months and years. At the end of COPIM, 71 libraries have signed up to at least one membership package, garnering 120 annual subscriptions across both publishers that will be used to pay for new OA front list titles. The model was also a finalist at the ALPSP 2021 'Innovation in Publishing' Awards.

And since its launch in late 2022, the *Open Book Collective (OBC)* platform and model is similarly garnering high levels of interest from and engagement with libraries. Its outreach work commenced in March 2023. Even in this short period, the OBC team has secured contracts with 25 institutions – including Amherst College Library, Cambridge University Libraries, Iowa State University Library, KU Leuven Libraries, Lafayette College Library, Lancaster University Library, Liverpool John Moores University Library, Macalester College Library, Oxford Brooks University Library, The National Library of Finland, Université de Neuchâtel, University of Bristol Library, University of California Santa Barbara Library, University of Coventry Library, University of Liverpool Library, University of Loughborough Library, University of Manchester Library, University of Michigan Library, University of Pennsylvania Libraries, University of Salford Library, University of Sheffield Library, University of Sussex Library, University of Wollongong Library, University of York Library, and Western University of Australia Library – and has now been able to generate £150,994 in invoiced income.

During the last 18 months of the project, all 7 Work Packages have been very active in promoting COPIM's proposed alternative vision through [reports](#), [presentations](#) and original research. A list of detailed outputs is available in the [Appendix](#) section.

## Challenges

In the context of the unprecedented global upheaval that impacted all aspects of the project's delivery, COPIM's main challenges included:

- Brexit and its impact on the economy, with the British Pound's intermittent loss in value, which has been affecting project payments to US- and EU-based partners particularly; and the corresponding uncertainties around the viability of contractual setups with international partners (EU, US), and their future sustainability due to the increased possibility of changing legislation (e.g., GDPR and the ongoing uncertainty around the UK's future (non-)compliance).<sup>4</sup>
- The impact of the **coronavirus pandemic**. Similar to the project's first two years, COVID-19's effect on the Higher Education sector became very tangible in quite substantial ways, resulting in a shrinking of the budgets available to a sizeable portion of COPIM's external stakeholders,<sup>5</sup> which in turn has impacted on the willingness to engage in the transformative approach that COPIM is proposing. On a more pragmatic level, the pandemic's impact on the project's recruitment strategy, as many of the partners were seeing recruitment limitations enforced in their institutions during the first two years (such as not allowing employees to work outside of the country in which the institution is based, even during periods of lock-down), which in turn led to delays in getting some of the open WP positions filled. Next to these limitations, which in turn required substantial extra work well into Year 3 in order to navigate the resulting uncertainties and make up for intermittent delays, the pandemic also created a set of very personal challenges for the team: many team members were either dealing with a notable increase in care duties or had to observe quarantining due to the inherent dangers of direct contact with the virus to personal wellbeing and livelihood. This in turn substantially impacted on members' availability and called for a flexible approach to managing and adapting workloads across the project.
- The impact of the **Russian invasion of Ukraine, and related heat-or-eat crisis**. The invasion had a particularly haunting effect on the level of the project's engagement with its Advisory Board, as one Board member had to

flee their home town to shelter from bombardment. More generally speaking, the impact of Russia's aggression compounded with the other systemic crises wrought by Brexit and the pandemic placed an extra strain on COPIM members' health and wellbeing.

- Impact of **prolonged industrial action in UK Higher Education**. Further adding to the uncertainties that the project had to face, the cross-sectoral and still-ongoing waves of University and College Union (UCU) strike action in the UK to advocate for fair pay and conditions in Higher Education meant that project staff were unavailable during these periods, and a variety of project events had to be rescheduled towards the end of the project.

As was the case with the first two years, the project's last 18 months have been fraught with uncertainties and with the shifting of parameters. This has been particularly evident on the level of Outreach & Engagement activities: the pandemic has largely inhibited COPIM's ability to meet experts in the same physical space for the purpose of building community around the various project outputs. This also holds true for the team's engagement in internal team building, as well as face-to-face meetings (e.g., COPIM's biannual meetings). By approaching these challenges in a creative way, the team has succeeded in establishing a number of alternative channels for interaction, networking, and knowledge sharing which have helped COPIM to meet and even exceed many of its original Outreach targets. The team has also continued with iteratively updating the Risk Register, which will be included in this report's Appendix section.

The new modes of engagement made necessary by the health emergency have also led to an increase in workshops planned by COPIM members. In many respects, the updated mode of delivery has proven beneficial for COPIM, with increased efficiency in organising logistics and participants through a more streamlined setup also allowing the project team to include participants from a wider range of geographic locations, and further extending stakeholder engagement to regions that tend to be underrepresented in the larger OA discourse.<sup>6</sup> For COPIM, this has also meant a substantially reduced environmental footprint across all Work Packages, something the team has [reflected upon in more detail](#) in a set of interviews published for the 2022 edition of Open Access Week.

It needs to be noted, though, that while the move to online workshops has allowed for greater responsiveness, focus, and participation, deficits of this new mode of engagement also became apparent in the sometimes-burdensome increase of video meetings, with “[Zoom fatigue](#)” and the challenge of working across multiple time zones always looming around the corner. There was a loss of rich social interaction that in-person, face-to-face meetings offer, with a corresponding lack of ability to engage further with possible stakeholders in order to foster deeper in-person networking.

Nonetheless, it is safe to say that the underlying systemic problems that have become apparent during the early months of the pandemic have also pushed the team to reflect further on the ways in which the project’s work is made discoverable and reusable in a transparent manner.

## Outlook

We are grateful to Arcadia and Research England for their decision to continue their support of the ground-breaking work begun with COPIM via **Open Book Futures**, a three-year project led by Lancaster University that builds on the proof-of-concepts established within COPIM to make an alternative, community-led ecosystem for Open Access books become reality.

**The Open Book Futures** project (OBF) will significantly expand some of the key infrastructures created by COPIM in order to achieve a step change in how community-owned Open Access (OA) book publishing is delivered. Open Book Futures will follow the principles of ‘[scaling small](#)’ that have guided the COPIM project, further developing the infrastructures, business models, networks and resources that are needed to deliver a future for Open Access books led not by large commercial operations, but by communities of scholars, small-to-medium-sized publishers, not-for-profit infrastructure providers, and scholarly libraries.

Among its activities, OBF will deepen and accelerate the work of:

- the [Open Book Collective](#), which makes it easier for academic libraries to provide direct financial support to small- and medium-sized OA publishing initiatives;
- the [Thoth](#) metadata management and dissemination platform;
- the [Opening the Future](#) revenue model;
- the [Experimental Publishing Compendium](#);
- and the [Thoth Archiving Network](#).

Running from 1 May 2023 to 30 April 2026, Open Book Futures will extend COPIM's long-term impact and ensure that a wide range of voices have the opportunity to shape the future of open access book publishing. In order to amplify bibliodiverse and equitable community-led approaches to OA book publishing, OBF aims not just to strengthen existing networks in the UK and North America, but also to engage further with publishers, universities, and infrastructure providers in a diverse set of national and linguistic contexts, including Africa, Australasia, Continental Europe, and Latin America.

With that in mind, Open Book Futures will reunite many of the COPIM project partners, including [Birkbeck, University of London](#), [Coventry University](#), [Directory of Open Access Books \(DOAB\)](#), [Jisc](#), [Loughborough University](#), [Open Book Collective \(OBC\)](#), [Open Book Publishers \(OBP\)](#), [punctum books](#), [Thoth Open Metadata](#), and [Trinity College, Cambridge University](#). They will be joined by a wide range of new partners including [Continental Platform/University of Cape Town](#), the [Curtin Open Knowledge Initiative \(COKI\)](#), the [Digital Preservation Coalition](#), the [Educopia Institute](#), [Knowledge Futures](#), [Lyrasis](#), [OPERAS](#), the [Public Knowledge Project \(PKP\)](#), [Research Libraries UK \(RLUK\)](#), [SciELO Books](#), [Scottish Universities Press/SCURL](#), and [SPARC Europe](#). The project is also supported by [Lancaster University Library](#).

COPIM project partners are delighted that Open Book Futures will carry the torch to significantly increase and improve the quantity, discoverability, preservation and accessibility of academic content freely and easily available to all.

## WP2. Revenue Infrastructures and Management Platform

WP2 has set out to develop and launch a modular, scalable revenue generation and management platform for open access books, to be made available to publishers and libraries.

At the end of the COPIM project, development was successfully completed and a proof-of-concept platform launched. In parallel, and working in close collaboration with Work Package 4, a dedicated community tasked with governing the platform has been established, culminating in the formal inception of the **Open Book Collective (OBC)**, now a CCLG registered in the UK currently in the midst of applying for full Charity status with the UK's Charity Commission. The Open Book Collective is overseen by a dedicated [Board of Stewards](#) comprising OA publishers, OA service providers, librarians, and OA experts, who collectively steer and govern the OBC's operations.

To facilitate all of the above, much of WP2's work during the last 18 months of COPIM has thus very much focused on Infrastructure Development to get the platform up and running, while simultaneously also establishing a dedicated Outreach plan to connect with as many libraries as possible in order to gather support for the new collective funding model being advertised through the platform.

All in all – and in common with the other Work Packages (see chapter 'Challenges') – WP2 has been impacted by the adverse effects that the set of above-mentioned systemic crises have had on team members' health and corresponding availability, which in turn have impacted on overall project delivery. Against this background, it seems noteworthy that the vast majority of Milestones, Deliverables, and Key Success Criteria that WP2 had agreed to deliver at project start have successfully been completed, albeit with some delay.

The Work Package has not fully reached two of the initial Key Success Criteria pertaining to the total number of subscriber libraries and corresponding total revenue generated by the platform, which is mainly due to the fact that the platform launch itself has been delayed, which has in turn delayed the start of the library signup rollout. In part this is due to a change of business model – as previously communicated, we shifted our focus from low levels of income received from high numbers of libraries, to a model of higher levels of support from – during the duration of the COPIM project at least – lower numbers of libraries. After launching the website, and a three-month period of testing and soliciting feedback from stakeholders, the OBC team launched an intensive outreach campaign in

March 2023. This has now generated contracts with 25 institutions –including Amherst College Library, Cambridge University Libraries, Iowa State University Library, KU Leuven Libraries, Lafayette College Library, Lancaster University Library, Liverpool John Moores University Library, Macalester College Library, Oxford Brooks University Library, The National Library of Finland, Université de Neuchâtel, University of Bristol Library, University of California Santa Barbara Library, University of Coventry Library, University of Liverpool Library, University of Loughborough Library, University of Manchester Library, University of Michigan Library, University of Pennsylvania Libraries, University of Salford Library, University of Sheffield Library, University of Sussex Library, University of Wollongong Library, University of York Library, and Western University of Australia Library. Thanks to these participating libraries' generous contributions to support the Open Book Collective, the team has now been able to generate £150,994 in invoiced income.

## Outreach Activities

During the third year, WP2 had successfully completed an additional set of workshops. Building on previous workshops, this comprised two major events focusing on outreach to libraries in the US and UK.

During these workshops, the WP2 team invited librarians to discuss how the Open Book Collective can best serve and communicate with scholarly libraries. It also solicited feedback on the proposed Membership Criteria and the platform and community's underlying values-led Governance model, its initial set of packages and initiatives and corresponding business model, community standards, technical aspects, and the general facilitation of libraries' selection of offers via the platform.

Following further development work – and thanks to the work of a dedicated team of Outreach specialists now mainly focusing on the US, Europe, and the UK – after the OBC's official platform launch in December 2022, WP2 launched its outreach campaign in March 2023. In just three months (March to May 2023), this has led to 22 university meetings in diverse national contexts, including the UK, USA, Canada, Australia, and a range of countries in the Eurozone. At the end of the COPIM project, the Open Book Collective is now well positioned to reach out to libraries in the US and the UK, while also working under the remit of the Open Book Futures project to further expand its Outreach activities to connect with libraries in Europe, Africa, Australasia and other parts of the world.

## Collaborative Research

During the final year of the project, the Work Package has focused its activities mainly on Infrastructure Development to get the consortial funding platform up and running, while simultaneously also working on intensifying outreach to the international network of libraries. Next to that, the Work Package has also been exploring questions of how to professionalise small and scholar-led presses, which has led to the publication of a major [Toolkit for Small and Scholar-Led Open Access Publishers](#), which serves as a resource aimed at smaller and/or academic-led Open Access book publishers which are either wanting to launch or to improve the way they operate, including independent presses and new/smaller university (or university library) led presses. In particular, the toolkit aims to help small publishers navigate the array of information that already exists online, but is often inaccessible because it is dispersed across different documents and resources. The OBC team plan to expand this resource as part of the wider 'OBC Information Hub' to be developed under the remit of the [Open Book Futures](#) project.

## Infrastructure Development

Building on the work completed during Year 2 of the project, WP2 has continued its collaboration with ΔQ Programming LLP to bring the **Open Book Collective platform** (<https://openbookcollective.org/>) to launch, which culminated in a successful platform release in December 2022.

In parallel, the Open Book Collective has implemented its **5-year financial / business plan**. This has evolved from the original outline submitted at the beginning of COPIM to also account for the systemic changes in the HE landscape produced by the pandemic.<sup>7</sup> As part of this business plan, the platform now presents a more comprehensive offer, extending beyond the initially-defined focus on the ScholarLed group of publishers alone, to include a wider set of OA publishing and infrastructure initiatives. As part of the new Open Book Futures Project, the aim is to generate £1 million in annual revenue by the end of April 2026, which – via the fees the Open Book Collective receives – would ensure its long-term financial stability, and deliver approximately £900,000 to the Open Access book publishing

ecosystem, either in direct payments to publisher / infrastructure provider members of the OBC, or in grants allocated via the Collective Development Fund.<sup>8</sup>

Further developing the outcomes of a set of governance workshops that had been conducted during Year 2, the **OBC's organisational model** has been published. It now comprises a clear outline of the Open Book Collective's Mission and Principles, its overarching set of values, the collective's identity and activities, a dedicated set of criteria that outline the conditions for membership for publishing initiatives and service providers, and an overview of the organisational structure underpinning the overall governance of the Open Book Collective.

WP2 has also published an **extensive discussion of the OBC's revenue model**, including contrasting it to the dominant model for financially supporting Open Access book publishing: Book Processing Charges (BPCs). As part of this, we explore the rationale behind the decisions we made, both in the spirit of transparency and for the benefit of other initiatives wanting to build on our work.

## WP3. Knowledge Exchange and Piloting Alternative Business Models

WP3 is dedicated to knowledge exchange and transfer, as part of the project's central commitment to dissemination. It builds pathways to impact with relevant stakeholders from across the sector, including publishers, (new) university presses, library-presses, scholar-led presses, academics, learned societies, and open technology developers.

To that end, WP3 has built on the foundational research and initial stakeholder engagement that had been put into practice during the first two years. Investigation into the legal and contractual prerequisites for setting up pilots to transition the business models of at least two extant publishers to new open access models bore fruit, and the pilot model is now advertised and actively taking subscriptions under the [Opening the Future](#) label. This is a collective library subscription model. It is underpinned by the idea that small contributions from a large number of academic libraries means that no single institution bears a disproportionate burden. In essence, library subscriptions to backlist books pay for new OA frontlist books to be published – a situation from which scholars and institutions around the world stand to benefit.

Technical and platform development led to the engagement of two publishers – Central European University Press and Liverpool University Press – and much of the work during the last 18 months has focused on further integrations with library acquisition workflows and invoicing, in conjunction with national network organisations Jisc (UK) and LYRASIS (US). Both pilot case studies have been fully operational since summer 2021, and WP3 has focused on outreach to libraries in order to be able to support these presses' OA models through individual sign-ups or via Jisc and LYRASIS.

*Opening the Future* has seen a lot of uptake since its launch: at the time of writing, the model's library membership has already accrued enough funding to publish 14 fully open access monographs, with three more already in production. And with libraries committing to multi-year memberships, both presses will be able to publish the same number of new OA frontlist books again next year.

Between the two presses involved, enough funding has been accrued through the scheme for approximately 45 titles to be published Open Access. With some libraries subscribing to memberships with both presses, *Opening the Future* now has a total of 71 library subscriptions secured, and 38 library membership subscriptions supporting both presses.




Fig. 3: Opening the Future: Library members

## Outreach Activities

In Year 3, outreach work in WP3 has primarily focused on extending the promotion of *Opening the Future* to an international library audience. To that end, the WP presented the model at a variety of national and international conferences and workshops, including sessions at: the Jisc/CNI Library Leaders conference; LIBER, UKSG and ALPSP; the German OA Tage conference; Society for Scholarly Publishers; the UK National Acquisitions Group; Canadian Association for Research Libraries; the Munin Conference; the Open Access Conference at San José State University, the Charleston Conference in the US; and RLUK.

Adapting what had originally been planned as the final in-person Work Package event, WP3 organised a major workshop in collaboration with RLUK under the title of ***Open Access Monographs: Making Mandates Reality***. This half-day workshop galvanised a much-needed sector-wide conversation on OA monographs in the context of the UK's policy landscape. Expert panels of speakers from the library, publishing and policy worlds outlined the current state-of-play and discussed how we can move to meet the imminent OA mandates from cOAlition S/Plan S in Europe and UKRI in the UK, and potential implications of the REF. Featuring expert speakers from UKRI and Jisc, the event combined a discussion of monograph policies and mandates with academic, librarian, and infrastructure provider viewpoints. All in

all, the event turned out to be a crucial workshop for academic library colleagues and anyone involved in academic book publishing interested to know how the sector will meet the challenges of open access monographs.

## Collaborative Research

Continuing with the research conducted in collaboration with colleagues in WP2 during Years 1 and 2, which had culminated in a widely-received **Scoping Report, [Revenue Models for Open Access Monographs](#)**, the Work Package focused on compiling a practical ‘toolkit’ that enables interested presses to convert their operations to OA-amenable business models.

The published toolkit, [Opening the Future: How to Implement an Equitable Revenue Model for Open Access Monographs](#), details how the Work Package has collaborated with the two pilot presses (CEUP and Liverpool UP) to implement this model. It includes a documentation of challenges, resources, timetables, and activities. It is intended as a roadmap for other presses that wish to implement an *Opening the Future*-esque model.


## Infrastructure Development

The continuous collaboration between WPs 3 and 2 intensified during the third year of COPIM. That led to increasingly aligned conceptual work, which explores the potential of integrating the *Opening the Future* model as part of the larger *Open Book Collective* platform offer. Looking forward, it is envisioned that during the next project phase of *Open Book Futures* (2023-26), a new set of presses seeking to convert their existing processes to OA-amenable business models will do so under the roof of the Open Book Collective platform.


## WP4. Community Governance

Work Package 4 has been conducting research to develop community-led governance procedures to support COPIM's open publication infrastructures for monographs. Building on the strong research-led conceptual, co-design, and outreach work that was begun during the project's first two years – and which led both to well-received workshop write-ups and a major initial research report on [models for Community Governance and their implementation](#) – WP4's research work during the last 18 months of the project culminated in the publication of two further research reports and in the finalisation and implementation of the [founding organisational governance model](#) of the Open Book Collective.

Leading on the formulation of a full-fledged organisational model, WP4 has continued its close collaboration with WP2. It has supported the Open Book Collective both during its formal incorporation as a Charitable Company Limited by Guarantee (CCLG), and in the set up and full implementation of its governance structures

## Outreach Activities & Community Building

Expanding the network of communities that had been established in Year 1 through COPIM's [Community Governance Workshop](#), and the **Community Governance Working Group** that has been set up on the [Humanities Commons platform](#), existing connections have been deepened and new connections developed through presentations on the topic of Community Governance and scaling small at a variety of international conferences and workshops.

Internal outreach with other COPIM WPs via a set of dedicated workshops has provided a clearer view on the variety of governance needs within COPIM. This is the case with respect to the infrastructures, models, and pilot projects the project is developing – most notably in connection with WP2's **Open Book Collective**, and WP5, advising the Work Package on **Thoth's** incorporation and governance model.

WP4 has also led on organising COPIM's end-of-project conference titled [Scaling Small: Community-Owned Futures for Open Access Books](#) which revolved

around the organisational philosophy of Scaling Small (which had previously been developed within WP4), and which functioned as both the final conference for WP4 as well as one of the main outreach events for the COPIM project as a whole.

Adding to the above, WP4 has led on implementing a bespoke **governance model** for the Open Book Collective (also see section *Collaborative Research*). This included assisting the OBC with its incorporation process and the drafting of its [Articles of Association](#), leading on its application to become a Charity with the UK Charity Commission, developing a [Diversity, Equity, Inclusion and Accessibility \(DEIA\) statement](#), a [Conflict of Interest Policy](#), and a [Code of Conduct](#). Further to that, WP4 has been supporting the OBC in administrative and management matter via the [OBC Secretariat](#), and on the OBC Board in the role of [Stewards](#) (Lidia Uziel and Eileen Joy).

## Collaborative Research

Building on the foundational research conducted in 2020 on best practices for the governance of open-source community-owned infrastructures, which culminated in the publication of WP4's first research report *Exploring Models for Community Governance*, the Work Package has further intensified its work on community-led governance structures. This has led to the publication of two major research reports:

- [Towards Better Practices for the Community Governance of Open Infrastructures](#) (2022), authored by Dr. Patrick Hart, Dr. Janneke Adema, and COPIM, looked to plot paths towards *better practices* for community governance by not shying away from the messiness, frictions, and compromises that of necessity come with the governance of open infrastructure in development. Next to that, this report outlined the process by which the COPIM project itself has developed its governance structures (mostly in relationship to the project as a whole, and to the Open Book Collective (OBC) platform and collective in specific): as a way to be open and transparent about its processes; to showcase in detail what developing community governance might look like in practice; and to document the process of doing so as a resource for the COPIM project itself and for the governance communities of its future infrastructural outputs.
- WP4's final report written by Dr. Judith Fathallah titled [Governing Scholar-Led OA Book Publishers: Values, Practices, Barriers](#) (2023) developed some of the issues the Work Package had previously explored within COPIM with regard to community governance, such as the challenges of governing a

collective and the relationship of governance to common resources. Doing so, the report explores how these apply in practice to small-to-medium Open Access publishers, as well as what barriers they have faced in implementing their governance models. It presents and discusses the results of six interviews with small and medium Open Access publishers from the ScholarLed consortium. It further offers recommendations and insights into how other small and medium Open Access publishers might set up and/or improve their governance practices, including how the Open Book Collective and Open Book Futures project can support them in doing so.

Continuing the work that had been established during the first two years of COPIM, the WP has deepened its close collaborations with other WP teams with a particular focus on the needs of WP2 and its requirements regarding practical implementation of governance in the context of the *Open Book Collective* platform and community. This has culminated in the successful formulation of a dedicated **[organisational governance model](#)**, including the official policies and procedures for self-governance and administrative management of the infrastructure. This model comprises: a clear outline of the Open Book Collective's Mission and Principles; its overarching set of values; the collective's identity and activities; criteria that outline the conditions for membership for publishing initiatives and service providers; and an overview of the organisational structure underpinning the overall governance of the Open Book Collective.

Following initial research into already-existing Codes of Conduct that was undertaken as part of the [first research report](#), WP4 drafted a first version of a Code of Conduct framed to the specific context and particular needs of COPIM's community. Members across all WPs were then engaged in an iterative process to further develop and finalise **[COPIM's Code of Conduct](#)**. The resulting document as well as a [documentation of the iterative process used to facilitate](#) both the creation of the Code of Conduct and other governance documents such as community statements on Mission, Vision, and Values, have been openly shared via COPIM's PubPub site.

## WP5. Building an Open Dissemination System

Throughout the project's lifespan, Work Package 5 has been guided by the perspective of new and emerging not-for-profit open access presses that have not yet been sufficiently integrated into existing discovery systems, knowledge bases, and supply routes. Its aim has been to develop methods and systems to better integrate the catalogues of open access publishers into curated research records. The implementation of 'best practices' workflows for OA book publishers helps with improving integration of their catalogues into the scholarly record (discoverability, reach, persistence), thus increasing the impact of OA books. To support this, WP5 has been building an Open Dissemination System (ODS), now labelled **Thoth**, for OA books and a shared 'best practices' digital catalogue.

During the last 18 months of the project WP5 has further increased its work on Thoth. Two publishers, Open Book Publishers and punctum books, have now fully adopted Thoth as their only metadata management system, while metadata from 18 other publishers – including a host of publishers external to the initial test case group of ScholarLed presses – has been uploaded into Thoth. Metadata files required for submission to an increasing range of distribution platforms, including Project MUSE, OAPEN, DOAB, JSTOR, Google Books, the Internet Archive, RNIB Bookshare, and EBSCOHost, are being created by Thoth. These files are now being used by the participating presses in making metadata submissions to these platforms. A new Export API has been implemented to facilitate this process.




Fig.6: The variety of export formats supported by Thoth at the end of COPIM (04/2023).

The Thoth Wiki has been expanded to include a [Thoth User Manual](#) to document usage and best practices. Adding to the documentation portfolio, a [series of use case interviews](#) has been created to showcase how utilising Thoth has helped each press with improving their internal handling of metadata management workflows.

To facilitate long-term and sustainable provision of the Open Dissemination Service beyond the life of the COPIM project, Thoth has successfully been incorporated as a Community Interest Company (CIC) in the UK at the end of 2022. To support the running of the company, a bespoke business model, comprising a two-tiered service approach geared towards publishers ('free' and 'plus' tiers) that ensures that the core service and API will remain freely available in perpetuity, has been developed. Adding to the mix of revenue streams that are envisioned to support the service with reaching sustainable operations, Thoth is now also part of the [Service Provider offer](#) available via the Open Book Collective, enabling libraries who wish to support open infrastructures to do so via the OBC's collective membership model.

## Outreach Activities & Community Building

Building on the realignment of WP5's outreach strategy that had become necessary early on due to the impact of the pandemic, research for the emerging scoping

report and the parallel continuing development of the Open Dissemination System (ODS), additional online workshops have been held during the last 18 months of the project. Workshops with ScholarLed publishers and others as well as networks such as the Library Publishing Forum and OASPA were arranged to introduce Thoth and to provide training and assistance with ingesting metadata to Thoth.

As part of Thoth's increased development activities, substantial efforts have been made to scope connections and further exchange with key stakeholders in the book dissemination landscape. Meetings have been held (e.g., with EBSCO, Jisc, NISO, Memory of the World, and Google Books), and input sought from university presses, libraries and publishers.

In addition to the above, Thoth has been a pilot case for integration into the [European Open Science Cloud ecosystem marketplace](#) via the [EOSC Pillar project](#), and further connections have been developed with like-minded initiatives active in the field of discoverability and metadata dissemination. They include [OPERAS](#), the [COKI/BAD](#) project, [ScienceOpen](#), and the [Public Knowledge Project](#).

## Collaborative Research

To reflect the continuous evolution of WP5's scoping and development efforts, the team decided to update the major research report that had been published in Year 1. A major revision of WP5's "Building an Open Dissemination System" report had thus been [made available on PubPub in April 2021](#). The updated version reflects the integration of the report's recommendations into the [GitHub development trajectory](#) of Thoth, and the [public Wiki](#) has been evolving in parallel to publicly document the different platforms and outputs that Thoth aims to connect to and/or facilitate provision thereof.

Further research has been conducted in close collaboration with the variety of publishers that are now using Thoth as part of their workflow, with a set of case study interviews having been published in the first quarter of 2023. In this [series of interviews](#) with representatives from small, scholar-led and born-OA presses (mediastudies.press, Open Book Publishers, and punctum books), interviewees spoke about their decision to switch their metadata management system to Thoth, how it impacted each press's workflow, and which of Thoth's bespoke features have been the most useful in their particular setting.

## Infrastructure Development

During the last 18 months of the project, a substantial amount of development work has been completed to establish Thoth as a full-fledged service and intuitive platform that enables publishers to create, update, and disseminate their metadata records to a variety of key aggregator platforms such as Google Books, Project MUSE, and JSTOR.

In line with the strategic vision to develop the ODS as a tool and service offer that aims to provide a viable alternative to the heavily fragmented book metadata ecosystem, WP5 has also increased in-depth scoping efforts to learn more about established publishing workflows at university presses and other interested publishing stakeholders.

These scoping efforts culminated in the prioritisation of output formats that are now being supported by Thoth. Supported formats now include KBART, JSON, CSV, MARC, MARC21, MARC21XML, BibTeX, and a variety of platform-specific flavours of ONIX records. Further to that, chapter-level metadata and the capability to facilitate automatic registration of DOIs via Crossref have been implemented in Thoth to date.

Thoth's platform and service are now fully operational. The project code and [general progress](#) of this development project have been made available in an open and transparent way via an Apache 2.0 licence applied to all software, the code of which is available via [GitHub](#). Meanwhile all of Thoth's metadata is [openly licensed as CC0](#) and is accessible via Thoth's open APIs (see Thoth's main [website](#)).

## WP6. Experimental Publishing, Re-use and Impact

WP6 aimed to align existing open-source software, technologies, workflows and infrastructures for experimental publishing more closely with the workflow of open access book publishers. To realise this goal the work package co-developed a set of pilot projects for the production of experimental books (in collaboration with, amongst others, the scholar-led presses Open Humanities Press, Mattering Press, and Open Book Publishers) which are created with the aid of these new tools and technologies.

Over the last 18 months, WP6 finalised three pilot projects, including the development of experimental books, workflows, and the extensive documentation accompanying these. It has also organised its final Experimental Publishing Conference and launched the Experimental Publishing Compendium.

### Outreach Activities & Community Building

Following in the footsteps of the set of experimental publishing workshops conducted during Years 1 and 2 in close collaboration with presses and platform and technology providers, the Work Package's outreach efforts towards the end of the project have culminated in the organisation of a conference titled [\*Experimental Books: Re-imagining Scholarly Publishing\*](#), which has been held online in early 2023.

Focusing on the communal nature of the experimental pilot projects conducted under the remit of WP6, and their performative potential in the context of academic knowledge creation and dissemination, the conference showcased some of the experiments that are currently taking place in the realm of academic book publishing. During the conference, experimentation was discussed and enacted as a way to: reimagine and re-perform established ways of conducting and publishing research and the implications for conceptions of individual authorship, originality, and the ownership of research that comes with this; questioning notions of the book as fixed and subject to rigid definition, along with the accompanying workflows, practices, and relationalities that constitute academic research, writing, and publishing.

The conference was organised around the three key themes or [\*book typologies\*](#) that the Work Package has explored and experimented with over the last 3.5 years in the context of the COPIM project. These are **Data Books**, which are books where a database forms the central element (i.e., not as an enhancement to a text-based book) around which the book is formed; **Combinatorial Books**, which are books based on the re-use (for example, through re-writing, adaptation, remix, or forking)

of already existing books published under an open licence; and **Computational Books**, which are books that include or incorporate code as part of their critical content or that execute or run code as part of their knowledge production or publication process.

Next to the Experimental Publishing Conference, the Work Package team has finalised work on three pilot projects of experimental book publications in close collaboration with publishers and authors:

1. The [Performing Patents Otherwise project](#) focused on data books, working together with Mattering Press and the [Politics of Patents](#) project (Goldsmiths, University of London). The outcome of this pilot project is a database book (i.e., a book that either contains a dynamically searchable database within its pages, or itself is generated from a database). Developing the book, the team explored how texts and books relate to the archive, and how digital tools complicate this relationship while also opening ways to render them more dynamically – and potentially available to open and ongoing interpretations. The following [blogpost](#) provides documentation of the project and the database book is available [here](#).
2. Developed in close collaboration with Open Humanities Press (OHP), the newly-established [Combinatorial Books: Gathering Flowers](#) book series explores and encourages the revisiting and rewriting of books within the OHP catalogue as a means of generating radical new responses to them. The first book published within the series, authored by a group of scholars, technologists, and students from Universidad Iberoamericana Ciudad de México (including [Etelvina Bernal](#), [Sandra Hernández Reyes](#), [Sandra Loyola Guízar](#), Fernanda Rodríguez González, Yareni Monteón López, Deni Garciamoreno, [Nidia Rosales](#), [Xóchitl Arteaga Villamil](#) and Carolina Cuevas), and edited by Dr [Gabriela Méndez Cota](#), is a book-length response to OHP's *The Chernobyl Herbarium* (2016). This has now been published under the title [Ecological Rewriting: Situated Engagements with The Chernobyl Herbarium \(PubPub version\)](#). The pilot project developed and openly documented a new technical, editing, and publishing workflow for OHP to produce combinatorial books, including an open peer review process, and recommendations for licensing and preservation.
3. Based on the [Promoting and Nurturing Interactions with Open Access Books](#) research report, WP6 advised TIB Hannover and the LIBER Citizen Science Working Group in the development of an [open peer review process](#) for their [Citizen Science for Research Libraries—A Guide](#), which explores ways to

assist research libraries in setting up Citizen Science programs at their institutions.

4. Collaborating again with TIB Hannover's [Open Science Lab](#), together with the German [NFDI4Culture](#) consortium, and Open Book Publishers, WP6 developed a Pilot Project on Computational Book Publishing. The aim was to create a working prototype or proof of concept for the publication of computational books – based on real (sample) digital objects – and to adapt this to the publishing workflow of Open Book Publishers. WP6 created [technical models and workflows](#) and two working prototypes, the [ScholarLed catalogue](#), and the Baroque paintings [exhibition catalogue](#). The objective was to test automatic retrieval of remote media and linked open data sources and then auto-typesetting the collated publication as multi-format output. The resulting prototypes have been made available for community reuse to enable others to produce their own computational publications, and are accompanied by documentation and a [step-by-step guide](#).

The WP team has openly documented the processes involved in the experiments conducted as part of all three pilot cases in a [series of blog posts](#), reflecting on the processes involved when practising experimental publishing.

## Collaborative Research

Building on the successful completion of the WP's two research and scoping reports, [Books Contain Multitudes: Exploring Experimental Publishing](#), and [Promoting and Nurturing Interactions with Open Access Books. Strategies for Publishers and Authors](#), the Work Package team have used the data compiled for these reports to release the beta-version of a comprehensive online toolkit: the **Experimental Publishing Compendium**. The Compendium serves as a guide and reference for experienced practitioners as well as those just setting out to experiment with the forms, content, and practices of scholarly bookmaking. The Compendium has been released as part of COPIM's end-of-project conference. It maps and situates experimental book publishing and provides a typology of experimental books together with an overview of practices and tools that can support experimental book publishing.

In doing so, the compendium provides an overview: of experiments with the form and format of the scholarly book; of the various (multi)media that long-form research can be published in; and of how people produce, disseminate, consume, review, reuse, interact with, and form communities around books.

Far from a mere formal exercise, experimental publishing, as conceived by the Work Package team, here reimagines the relationalities that constitute scholarly writing, research, and publishing. Books are understood to validate what counts as research, materialising how scholarly knowledge production is organised. It is hoped that the entries listed in, and cross-linked throughout the Compendium, may inspire speculations on the future of the book and the Humanities in more general terms, and encourage publishers and authors to explore publications beyond the standard printed codex format.

## **Infrastructure Development**

Finishing the design and development work that was begun during Year 2 with a comprehensive update to the research and scoping reports, the Work Package has successfully released an Experimental Publishing Compendium (see above).

Further to that, and in close collaboration with the COPIM developer, the presses and author communities involved in the WP, the team has also completed its work on documenting the technical and publishing workflows for the three experimental book pilot projects.

## WP7. Archiving and Digital Preservation

Work Package 7 has been working: to identify the key challenges associated with archiving research monographs in all their variation and complexity; and to develop new solutions to integrate research monograph archiving and preservation aspects into dissemination workflows. Doing so, the WP's focus has been on the archiving and preservation of open access monographs, with specific attention being paid to the small and scholar-led OA monograph press. These presses have unique challenges in this area (as detailed in the WP's first [Scoping Report](#)), and will face difficulties with being able to meet the potential funder requirements that may arise.

With that in mind, the WP team has focused largely on the creation of a network of institutional repositories and the Internet Archive, the newly-established [Thoth Archiving Network](#), in which participating presses may easily deposit their monographs via Thoth, the Open Dissemination System developed in WP5.

### Outreach Activities & Community Building

Building on a variety of connections with external stakeholders developed out of a first Scoping Workshop in 2020, the Work Package has organised two further workshops in 2022 and 2023. Existing outreach activities have been deepened and close liaisons sought e.g., with the [Embedding Preservability](#) project, the British Library, the Digital Preservation Coalition, the Internet Archive, and Jisc.

The November 2022 workshop, aimed at UK Repository Managers, was focused on the newly-established [Thoth Archiving Network](#) (TAN) that has been developed in close collaboration with WP5. It discussed the benefits as well as challenges that a community-led network structure relying on repository structures already existing at partner libraries might be facing.

The March 2023 workshop [investigated copyright questions in relation to archiving and preserving open access monographs](#). In doing so, the workshop brought together members of the COPIM project, copyright experts, preservation experts, librarians, and OA publishers chosen both for their specialisms and their expert knowledge. The aim was to ensure the inclusion of a range of perspectives.

## Collaborative Research

Building on WP7's [initial workshop](#) on archiving and preservation of OA books, additional scoping work and a dedicated literature review had been conducted, all of which subsequently fed into the [Scoping Report on Archiving and Preserving OA Monographs](#). This comprehensive document provides an overview of existing preservation solutions for Open Access (OA) research monographs, brings together interviews conducted with representatives from several university presses and OA presses, and draws on discussions that took place during the above-mentioned workshop with a range of professionals in the archiving and preservation domain.

Another key output of the Work Package has been the [‘Good, Better, Best’ Practice guide](#), which closely examines areas of archiving and preservation practice for the small or scholar-led publisher pertaining to metadata and file formats, the selection and packaging of content, existing routes to digital preservation, as well as archiving-specific issues with copyright, reuse, and licensing and with complex & experimental monographs. The approach of different practice levels has been chosen with the existing diversity of presses in mind, acknowledging that not all publishers will have the same level of resources available regarding financial means, staffing, and/or technological expertise.

## Infrastructure Development

Working in close collaboration with WP5, WP7 has scoped a variety of workflows to link repositories with publishers. Together with the Internet Archive and Loughborough's institutional repository, a proof-of-concept for the Thoth Archiving Network has been established. The team have also tested workflows with two other universities and their associated repository software. For this network, a set of approaches have been devised to [facilitate automated depositing](#) of outputs via Thoth. In parallel, this work allowed the team to explore additional preservation-specific metadata, which were subsequently fed back into the development of Thoth, WP5's Open Dissemination System.




Fig. 8: Overview: Total visits and total downloads of the various reports published by COPIM between 2020-23. Usage data collected May 24, 2023.








