I 100% sponsored you in Australia from my PhD Scholarship money (around 1500000BDT). You signed spouse visa requirement to accompany me in Australia. You know that Melbourne is very expensive City. Still now you are staying with me after more than one year. I faced criminal attack in Melbourne. The issue was life-threatening, I told you again and again, but you tried to neglect/divert the issue. There is different type of criminal who may have illegal arms, who may show financial advantage in different way. There is also possibility of life-threatening/artificial scam. You should not communicate with my official persons without my permission. You need to clarify everything for my protection and your protection. A true speaking may protect from mis-understanding. A true speaking may be a protection of future. I do not know why do you need a lot of money anyhow and any way; it may be an embarrassing issue of your life when I am sponsoring you 100%. Allah protected from criminal attack in Australia.

In Australia and Bangladesh, you repeatedly wanted to leave my residence and wanted to stay separately, why?

In Australia and Bangladesh, you repeatedly threatened to go police, why?

In Australia and Bangladesh, you frequently threatened me to use 'knife', why?

In Bangladesh, you frequently threatened for a combine meeting with the people of seven village, why? I am waiting for your meeting since August 2022.

After coming from Australia, you are forcing me for divorce in different way, but you are not leaving my accompany, why? What is your intention?

In Australia and Bangladesh, you told me again and again, "why didn't die through criminal attack", why? Is it my marriage condition that I should die? What is your benefit if I die?

Under consequence of your suspicious behaviour, I showed you psychological doctor immediately after marriage (2018), after going to Australia (2021) and coming back from Australia (2022). You have no tendency to continue your medication directed by doctor.

Second incidence on 10 August 2023 in my residence premises Village: Purbo Nuthurchar (1990), Post Office: K. Mohonpur, Gopalpur, Tangail. Possibly you invited Mr. Farid and his wife. You arranged a sudden meeting without my permission and Farid showed attacking attitude with me. Under embarrassed situation, I shouted with Mr. Farid and requested to leave the residence premises. You shouted for calling Mr. Sumon immediately. You threatened for telling Mr. Sumon, why? What is your intention? Who is this Sumon? Please clarify by written letter?

First incidence on June-July 2022 in my residence premises Village: Purbo Nuthurchar (1990), Post Office: K. Mohonpur, Gopalpur, Tangail. You possibly invited Mr. Farid at Village residence, and jointly shouted and quarreled with my mother. You telephoned me and shouted. You tried to prove your close relationship with Mr. Farid.

After coming from Australia (2022), you told me the word of Mr. Sumon that he will make a 'shoe-chain' for me and he will hang the "shoe chain" on the throat of me. This word of humiliation is totally breaking the civilization of human being. Please clarify that Mr. Sumon told you regarding this verbal abuse of "shoe chain" or you told me. Could you please tell me for next stage investigation, who is this Sumon?

You invited Mr. Farid in Dhaka residence at House: 48, Road: 01, Charabag Madrasa Circle, North Road, Ashulia, Savar without any reason and without my consent. You showed very close relationship with Mr. Farid.

If you do anything without my consent, I will not be able to protect you as your husband if someone intend to harm you. If you harm yourself and if you tell lie, you should be responsible for everything as per government law as you are more than twenty-five years old, you are not a child now. In some way, you told me that you have 'hidden earning' of Australian Dollar in Australia. I married you as per Muslim law. If you are disagreeing to obey the muslim law, you should not stay with me. If you have huge lacking of sexual response. Why did you marry me?

You have tendency of shouting by showing disobedience and shameless attitude with me and my mother which is not good as per Muslim relationship. One day you stopped distributing the food for mother in a same dining table we started to eat, is it preferred by any human being? Regularly you do verbal abuse my mother and you have threatened for denial of food. You always show bad attitude with my mother, why?

You did my psychological harm in Bangladesh and Australia during my PhD research funded by Australian Government Scholarship. Presently, you have also bullying/forcing of taking 'baby' immediately. In Bangladesh, I also funded for your master degree and forced to continue your study. I had also a good plan to develop you accordingly. I was trying to provide you living, fooding, medical, schooling, clothing, conveyance, telephone allowance, cosmetic allowance, diabetics allowance and everything under my ability of professional earning. If you are not happy you will not stay with me. You will not stay with me only for baby. Please you should stay with me for me.

It is a remarkable issue that after going to Australia your behavior was gradually changed. You also threatened to leave my accompany. After involving casual job in Australia (2021), your behaviour was completely changed. You earned around 500000BDT and completely sent to your brother, Mr. Mithun. I completely paid for your return air ticket for coming back to Bangladesh. You showed interest for doing job. I helped you for your job as per recommendation of your elder brother, Mr. Momin and Mr. Mithun, is it my crime as per government law of Bangladesh/Australia. After having job (around six-month duration) in Australia, you started to disrespect me.

You threatened me to make police report in terms of violence against woman on 23 February 2023, why? Could you please clarify by written?

You threatened me to make police report in terms of violence against woman on 10 April 2023, why? Could you please clarify by written? You pinched few places in my throat with fingers on 10 April 2023. You broke few necessary materials at residence premises in village, why?

In my whole marriage life, what type of harm I did, could you please make a complete list and send me accordingly. If you cannot make any list, you should be liable for compensation of harming me when your harassment can not be converted into currency.

You told me on 7 March 2023 that I will get pension after having PhD degree. Who told you to make this misunderstanding? I didn't tell you that I will get pension after having my PhD

You also called few people for discussion in terms of sudden shouting at midnight around 12 am. What was your intention? Please clarify me by written letter.

Second part of incidence on 8 February 2023

You entered in my sleeping room; you approached attacking attitude with my wife (Mrs. Sharifa Akter). You hardly wanted to beat my wife at the ear corner (very sensitive place of a person). I also hardly requested to leave the residence immediately and respectfully by ‘two-hand’ showing request. My mother was seriously afraid and shouted a lot at night. My mother repeatedly shouted and told that “protect us and protect us”. This is a verbal crime as per criminal law of Bangladesh Government. You shouted and told me “Shamim is nothing” and you don’t count Shamim. If you don’t count someone, is it important to inform me at 12 am? Who is this “Shamim” in the local village. You need to clarify accordingly if it is necessary to make any investigation. Please respectfully send this copy to your identified Shamim by next three days to avoid any future occurrence.

An audio-based recording of incidence on 8 February 2023 in my residence premises, Village: Purbo Nuthurchar, Post Office: K. Mohonpur (1990), Gopalpur, Tangail may be heard in judge court.

Second incidence on 10 August 2022 in my residence premises Village: Purbo Nuthurchar (1990), Post Office: K. Mohonpur, Gopalpur, Tangail

You visited my village residence on 10 August 2022 and immediately approached to talk with me. I was fully disagreed to talk with you to avoid any unexpected shouting under your bullying of discussion. You hardly shouted, humiliated and showed attacking attitude with me on 10 August 2022. I was inside the door in a room and you hardly tried to cross the door again and again under attacking body language; and my mother was the barrier in the middle side. You shouted a lot in my residence premises and told me that “you are the main troublemaker”. You also verbally forced and tried to bring my wife from my residence. You also told me that you will do and show something later (I am writing this letter after six month waiting period to signify your next stage attitude). Could you please clarify your shouting purpose by written letter? I requested that you should not come in my residence to meet with my wife. I, Md. Anowar Hossain also shouted to leave the residence premises immediately to avoid unexpected incidence and still you continued to shout behind the door and house premises; and you left the residence after 30-40 minutes.
