Standards of Care

- e.g. Metformin -- the gold standard in type 2 diabetes management
- Guidelines from the professional societies
- ISO 9000 series Quality Management System
  - Application of ISO 9000 in health
- Voluntary standards and standards supporting regulations
  - e.g. Medical Device Regulation

#### **About CEN**

- The European Committee for Standardization
  - Comité Européen de Normalisation
  - Brings together National Standardization Bodies from 34 European countries
  - Is one of three European Standardisation Organizations, together with
    - CENELEC Electrotechnical
    - ETSI Telecommunications
  - Responsible for European Standards that can be used to support EU legislation and policies

## Scope & mission

- CEN/TC 251 'Health informatics' = information engineering applied to the domain of health
- Members: having a strategic and responsible position in the standards arena in the EU and affiliated countries including the United Kingdom, Norway, and Switzerland.
- Mirroring & cooperating closely with <u>ISO/TC 215</u> 'Health informatics'.
- Active member as one of the thirteen members of the <u>Joint Initiative</u> <u>Council for Global Health Informatics Standardization (JIC)</u>. Part of the vision is to achieve widespread adoption and use of harmonized health informatics standards, where a singular set of standards is recognized as addressing each health business need.

  - To be used for both patients, providers and authorities for assessing the quality and reliability of apps


