What is a Standard ?

“A technical specification adopted by a recognized standardization body for repeated or continuous application with which compliance is not compulsory”

European regulation on standardization 1025/2012



Benefits of Standards

- Assist trade by eliminating technical barriers
- Promote interoperability of products and services
- Promote new technologies and good practices
- Increase safety of products and protect consumer, environment, health and safety etc
- Assist with compliance with legal obligations



Standards supporting regulations

Harmonised Standards

“A harmonised standard is a European standard developed by a recognised European Standards Organization (CEN, CENELEC, ETSI). It is created following a request from the European Commission to one of these organizations. Manufacturers, other economic operators or conformity assessment bodies can use harmonised standards to demonstrate that products, services or processes comply with relevant EU legislation”

Manufacturers responsible for product safety
& “placing on the market”

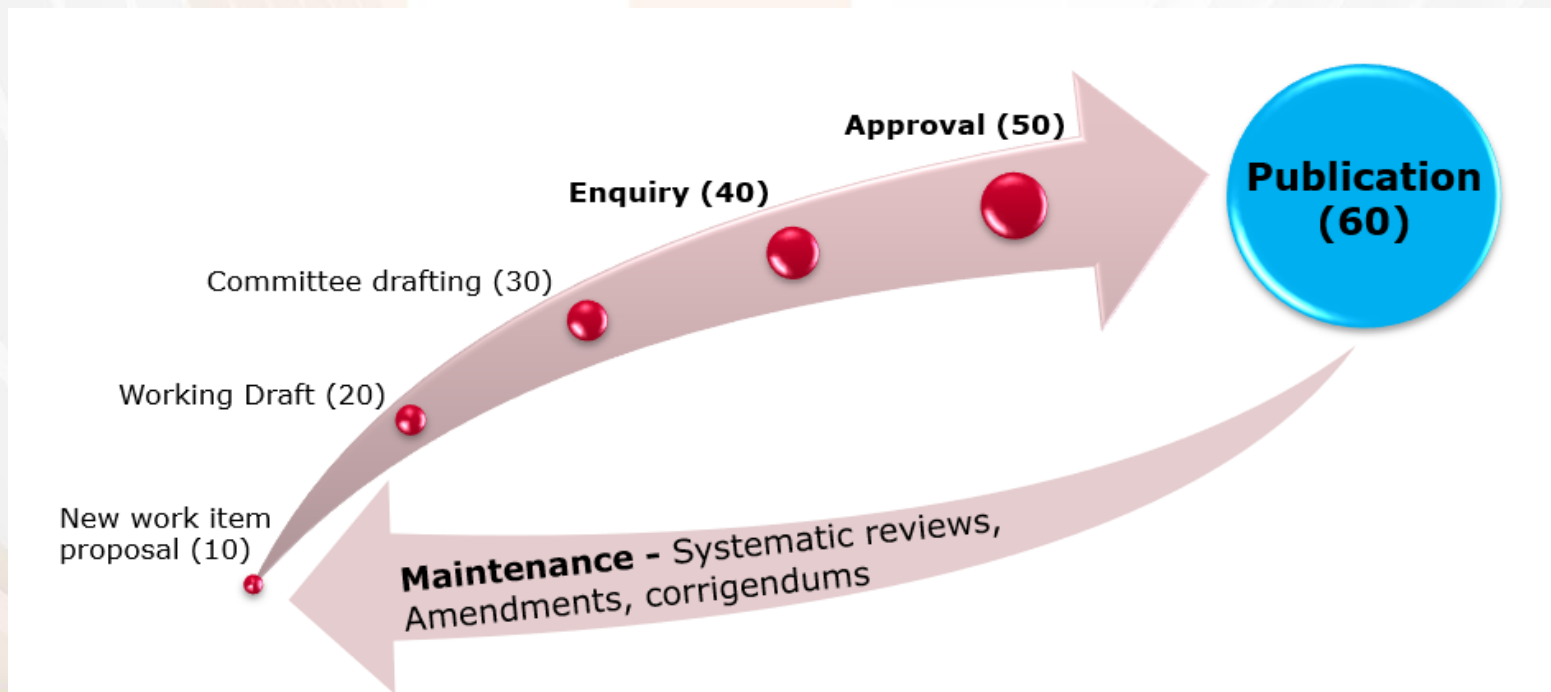




Types of Standard Deliverables

Type of Deliverable	CEN/CENELEC	ISO/IEC
Standard – EN/ISO	EN – Normative, adopted by CEN-CENELEC, <u>obligation of national implementation</u> & withdrawal of conflicting national standards – <u>consensus achieved</u>	ISO/IEC – Normative, approved by members, consensus on rules, characteristics or results for optimum order in a given context – <u>consensus achieved</u>
Technical Specification - TS	CEN TS – Normative, Topic still developing, future possibility of agreement on a European Standard- <u>not full consensus</u>	ISO TS – Normative, topic under technical development – possibility of a future International standard – <u>not full consensus</u>
Technical Report - TR	CEN TR – Informative material not suitable to be published as an EN or a TS e.g. data on the “state-of-the art”, data obtained from a survey etc	ISO TR - Informative - data or information on perceived “state of the art” e.g. informative report or survey results.
